Your FlexScreen carries a limited lifetime warranty for any defects that arise that would prevent the product from effectively deterring the entry of insects into your home. This limited warranty is valid only for the original consumer purchaser ("the Consumer") and is not transferable to any subsequent purchaser. No limited warranty service is available without registering your FlexScreen within 30 days of retail purchase.

FlexScreen, LLC ("Warrantor") will repair or replace, at Its option, this product during the limited warranty period, subject to the exclusions and limitations set forth herein. Any replacement will be made with a new product. If the product is no longer available, replacement may be made with a similar product of equal or greater value. This is your exclusive limited warranty.

Should any failure covered by this limited warranty occur, the Consumer must provide proof of the failure to Warrantor. This may require the Consumer to deliver or ship the product to FlexScreen, LLC. All freight, packaging and transportation charges, including costs associated with any shipment of the product to Warrantor and any shipment of the repaired or replacement product back to the Consumer, will be borne by the Consumer, in order to be eligible for repair or replacement under this warranty, you MUST return the warranty registration card within 30 days of purchasing your FlexScreen. Keep the original sales receipt. Proof of purchase is required to obtain warranty performance. Retailers do not have the right to alter, modify, or any way change the terms and conditions of this limited warranty.
