THERAPEUTIC AND DEVELOPMENTAL PROGRAMMING INCLUDES RECREATIONAL
THERAPY, OCCUPATIONAL THERAPY, NUTRITION EDUCATION, STEM-BASED LEARNING
OPPORTUNITIES, AND WORKFORCE READINESS INITIATIVES DESIGNED TO BUILD
LIFE SKILLS, CONFIDENCE, AND LONG-TERM INDEPENDENCE. THESE SERVICES AIM
TO PROMOTE COGNITIVE DEVELOPMENT, PHYSICAL ENGAGEMENT, AND FUTURE
PREPAREDNESS FOR PEDIATRIC CANCER PATIENTS AND SURVIVORS.

FAMILY-CENTERED CARE IS A CORE COMPONENT OF THE FOUNDATION'S MODEL.
PROGRAMS ARE DESIGNED TO SUPPORT THE ENTIRE FAMILY THROUGH SOCIAL AND
BEHAVIORAL COACHING, INDIVIDUAL COUNSELING, FAMILY COUNSELING, GRIEF
COUNSELING, AND COGNITIVE BEHAVIORAL THERAPY. THESE SERVICES PROVIDE
TOOLS FOR EMOTIONAL RESILIENCE, COPING, COMMUNICATION, AND HEALTHY
FAMILY FUNCTIONING THROUGHOUT AND BEYOND THE CANCER JOURNEY.

ADDITIONAL PROGRAMMING, INCLUDING INDUSTRIAL ARTS AND HANDS-ON SKILL
DEVELOPMENT, FURTHER SUPPORTS COGNITIVE ENGAGEMENT, CREATIVITY, AND
PERSONAL GROWTH FOR CHILDREN AND ADOLESCENTS.
THROUGH THIS COMPREHENSIVE CONTINUUM OF CARE, THE AUSTIN HATCHER
FOUNDATION SEEKS TO REDUCE THE PSYCHOSOCIAL BURDEN OF PEDIATRIC CANCER
AND EMPOWER CHILDREN AND THEIR FAMILIES WITH THE SKILLS, SUPPORT, AND
RESOURCES NEEDED TO NAVIGATE TREATMENT, SURVIVORSHIP, AND LONG-TERM
WELLBEING.
