Although the number of TMS schools/locations and overall youth served remained consistent from the previous year 2023, in 2024 we were proud to announce a new partnership with the SEED DC Charter School, which for the grant period, became the new home of the Washington Youth Choir and our Music Industry Development Program which served high school aged youth. Also, through \$10,000 of renewed funding support provided by a family foundation, we launched our first ever Music Therapy program targeted to High School Students This was the first ever opportunity that allowed us to deliver a full suite of TMS educational programs at one designated location. In addition, TMS received second time MADDC Grant Funding from the DC Mayor's office to launch an after-school program at Brookland Middle School.
