FEES EXPLAINED

The **student levy** covers curriculum resource costs including year level camps, excursions, incursions, magazine & school photos, and includes lease, warranty, insurance, software licensing and network services for student devices. The **capital levy** is to assist with minor building program projects and improvements.

The student and capital levies are not eligible for pro-rata or family discount.

Enrolment administration fee

To confirm enrolment, a non-refundable enrolment administration fee of **\$400** is payable.

Charter bus

The subsidised Mater Christi charter bus is charged separately. Please apply by completing the 'Charter bus application' form available from the College website.

Sibling discount

The College discounts the annual tuition fees for siblings attending Mater Christi concurrently, based on family position.

Catholic family discount

The College's Catholic family discount of **\$500** is available as a reduction against Mater Christi fees, for families who have one or more sons attending any Catholic secondary school.

Please apply by completing the 'Catholic family discount' form available from the College website.

Early payment discount

A discount of **\$270** is applicable when the total school fee is paid in full by 20 November 2025.

Camps, sports and excursion fund (CSEF)

Health Care Card, Veterans Affairs Gold Card or Pension Card holders may be eligible.

Conveyance allowance

Students who reside 4.8km or more from the College may be eligible for assistance with transport costs.

Refer to the College website for further information and application forms.

Payment options

Payment required by direct debit (via bank account or credit card) can be per term, monthly, fortnightly, or weekly.

First instalment is due by 20 November 2025, with final payment of the year's fees due by 20 October 2026.

Please complete the 'direct debit' form available from the MyMCC/FeeAccount.

Early withdrawal

A full term's notice (10 weeks) in writing to the Principal is required, in accordance with the conditions of enrolment, when withdrawing a student from the College, or 25% of the total tuition fee is payable in lieu of this notice.

The student and capital levies are not refundable or eligible for part year or pro rata discounts.

Late payments

Students may be ineligible for optional extra-curricular programs when payment arrangements are not honoured, and communication is not maintained.

We encourage any parent experiencing fee difficulties to contact the Finance Team.

Account statements

The October school fee statement shows the annual billing amount for:

- total school fees
- any relevant discounts
- charter bus.
