# How the Technology Works

The heart of any parking management system is the software that runs it. The best platforms can be customized to allow property owners and developers to address their unique parking management needs, as well as the unique needs of their tenants. The software stores information about each user's parking needs to build an individual use case for that user. The use case determines how the parking can be utilized, managing things like when and where the vehicle owner can park; whether they will be charged and, if so, how much; and whether the owner has access to a guest pass and, if so, how much they will be charged for each pass.

There's also a hardware component. Typically, license plate recognition (LPR) technology is integrated with the parking management platform to monitor entry and egress. The LPR cameras capture the license plate information of vehicles as they enter a complex, and they do the same when the vehicles exit. Upon entering and exiting, the system associates the stay with the appropriate permit.

The technology does more than manage parking sessions, however. It also collects utilization data and can be set up to analyze and report that data in whatever manner best meets owners' and property managers' needs. If the platform is integrated with a PARCS system (the gates that all entry and egress into parking areas), the data collected by both systems can be combined to provide a comprehensive look at who is parking in the facility, when, and where in the facility they are parking.
