TEACHING POSITIONS

Between 2004 and 2021, Edward was a Fellow of the University of Wollongong's School of Law; most recently as an Honorary Professorial Fellow. In that capacity, he convened and delivered courses in Corporate and Personal Insolvency as part of that University's Summer Session and contributed to the teaching of the Law of Contracts and Environmental Law at an undergraduate level as guest lecturer. He has delivered papers at academic gatherings and lectures to barristers, solicitors, and other professional bodies as part of their respective professional development programs. These papers and lectures have covered a wide range of topics, including: causation under the Civil Liability Act; evidentiary issues arising in the prosecution of environmental offences; the preparation of affidavits and expert evidence; professional indemnity; the interaction between the Professional Standards Act and policies of professional indemnity insurance from time-to-time approved for barristers by the Attorney General; intersections in the regulation of water resources and the criminal law; and various topics relating to both the law of insurance and the regulation of the legal profession.



Since 2018, Edward has chaired the committee tasked with delivering the NSW Bar Examination and, for a number of years, delivered workshops on professional ethics to exam candidates and assessed and provided instruction to participants in the NSW Bar Practice Course across a range of different areas.
