

Central to Business Port Macquarie's activity as the premier local business advocate, we pursue issues and opportunities which support a healthy economy and improve the quality of life in our community.

In this regard, Business Port Macquarie has consulted with and represented member views on a broad range of issues, including those detailed below. We also held Board Representation on the Cultural Steering Group.

Business Port Macquarie continues to lobby local, state and federal representatives in respect to the detailed design for upgrades for the Oxley Highway to improve traffic access to the Health and Education Precinct (HEP), including to the Port Macquarie Base Hospital and Charles Sturt University, Port Macquarie Breakwall repairs, disaster relief forum, 2024 North Coast Tourism Symposium, Education Youth and Business.

# Financial Statement

## 2024/2025 Treasurer's Report

On behalf of Business Port Macquarie, I am pleased to present the Treasurers Report for the financial year 2024/25. With lots of changes and challenges, I must thank the Board for their continued support. A big welcome to our new President Peter Jones. And our new Executive Officer Kylie Morris.

Managing income and expenses in our endeavours to run events, provide relevant information and content, plus provide an effective voice for Business is always a challenge particularly for not-for-profit organisations. Managing the dollars is always an interesting exercise – and again the board has done a fantastic job in mitigating this through the hard work of all.

Our Gross Income this year was \$276,600 a decrease of 31% on last year. This decrease however was attributed to the fact we did run the AICD Company Directors course last year which produced significant income as well as expenses. Expenses for the year was \$292,386. Which gave us a loss of \$15,786 but with retained profits of \$83,802. Other factors that impacted income was lower ticket sales for the Business Awards. Also understanding that our income is very much a cycle of payment timing from our members.

What was great to see was a 16.8% increase membership income, in dollar terms \$11,078. The Business Chambers Premier Event, the Annual Business Awards contributed \$117,448 down 4.85% from last year, with again the Annual Golf Day and other events including Boardroom lunches contributing to our financial position.

Again, our Sponsors contribute a large portion of our income. With sponsored events providing significant income to Business Port Macquarie.

Given the challenges of business, the current economic situation, and several business's closing down and/or moving away, it has been a challenging year for Business Port Macquarie. This is particularly evident in a loss of a number of members over the past twelve months. And whilst it has been great to see so many existing members renew – we have also had of number of new members come on board. The work that has been done by our Executive Officer Kylie Morris in retention and growth of members is an outstanding achievement

I would like to thank our President Peter Jones for his support, the wonderful team of Directors and Kylie Morris for the focus, commitment & drive to engage our Business Community.
