#### 2025 TELUS Friendly Future Sweepstakes

### **CONTEST RULES**

2025 TELUS Friendly Future Sweepstakes (the "Contest") is being conducted by TELUS Friendly Future Foundation (hereinafter referred to as the "Contest Sponsor"), and WestJet, an Alberta partnership, (hereinafter referred to as the "Prize Supplier"), and shall be construed and evaluated according to applicable Canadian law. The Contest is open to legal residents of Canada 18 years of age and older. Do not enter the Contest if you are not a legal resident of Canada 18 years of age and older. The Contest is void in whole or in part outside of the jurisdiction(s) expressly listed above and here otherwise prohibited or restricted by law. Entry in this Contest constitutes each entrant's acceptance of, and agreement to be legally bound by, these Official Rules and Regulations (the "Rules").

#### 1. **ELIGIBILITY**

The Contest opens at 12:00:01 a.m. Eastern Time ("EST") on October 27, 2025, and closes at 11:59:59 p.m. EST on December 5, 2025 (the "Contest Period"). All Entries must be received by 11:59:59 p.m. EST on December 5, 2025 (the "Entry Deadline").

**Note**: To qualify for the early bird prize, Entry/Entries must be received on or before 11:59 EST on November 12 2025.

## b. Essay

#### One (1) eligible winner per prize shall be selected as follows:

- a. The odds of being selected as the potential winner are dependent upon the number of eligible Entries submitted and received in accordance with these Rules. On December 12, 2025, at approximately 11:00 am EST at 25 York Street, Floor 30, Toronto ON, M5J 2V5 (the "Draw Date") will be completed by a TELUS Friendly Future Foundation representative, and a data pull for all eligible Entries will be completed and Five (5) potential winners will be selected by a random draw from all eligible Entries submitted and received in accordance with these Rules. Limit of one (1) Prize will be awarded per email, per person and per household for the duration of the Contest. Odds of winning depend on the total number of entries received.
- b. Following the Draw Date, the Contest Sponsor or its designated representatives will make no less than two (2) attempts to contact the eligible winner by phone and/or email, during the three (3) day period (the "Contact Period") immediately following the Draw Date. Upon notification, the eligible winner must respond by telephone and/or email to the contact provided in the notification, and the eligible winner's response must be received by the Contest Sponsor by no later than 5:00 p.m. EST on the required return date stipulated in such notification. If the potential winner does not respond in accordance with these Rules, he/she may be disqualified, at the sole and absolute discretion of the Contest Sponsor, in which event he/she will not receive the Prize and another potential winner may be selected from the remaining eligible Entries, in the Contest Sponsor's sole discretion, whom the Contest Sponsor or its representatives will attempt to contact, and who must respond or will be subject to disqualification, in the same manner (adjusting timeframes, including the Contact Period, accordingly). This section does not limit any other consent(s) that an individual may provide the Contest Sponsor or others in relation to the collection, use and/or disclosure of their Personal Information.

# **12. INTELLECTUAL PROPERTY**

All intellectual property, including but not limited to trademarks, trade names, logos, designs, promotional materials, web pages, source code, drawings, illustrations, slogans, and representations are owned by the Contest Sponsors/Suppliers and/or their affiliates. All rights are reserved. Unauthorized copying or use of any copyrighted material or intellectual property without the express written consent of its owner is strictly prohibited.

### **13. TERMINATION AND AMENDMENTS**

The Contest Sponsor reserves the right, to withdraw, amend or suspend this Contest (or to amend these Rules) in any way, in the event of any cause beyond the reasonable control of the Contest Sponsor that interferes with the proper conduct of this Contest as contemplated by these Rules, including, without limitation, any error, problem, computer virus, bugs, tampering, unauthorized intervention, fraud or failure of any kind whatsoever.

Further, the Contest Sponsor reserves the right to cancel, amend or suspend this Contest, or to amend these Rules, in any way without prior notice or obligation, in the event of any accident, printing, administrative, or other error of any kind, or for any other reason whatsoever.
