## **LIMITED HULL WARRANTY**

BLUEWATER SPORTFISHING BOATS warrants each new fiberglass hull to be structurally free from defects in materials and workmanship under normal care and use for a period of TEN (10) years from the date of purchase by the original purchaser.

BLUEWATER SPORTFISHING BOATS warrants all other parts of its own manufacture to be free from defects in material and workmanship under normal care and use for a period of ONE (1) one year from the date of purchase by the original purchaser.

BLUEWATER SPORTFISHING BOATS warrants the transom and stringers of each new fiberglass hull to be manufactured from foam materials which will not rot under normal care and use for the lifetime of the vessel from the date of purchase by the original purchaser.

BLUEWATER SPORTFISHING BOATS agrees to repair or replace at its option parts of its own manufacture found to be defective within this warranty period when returned to the manufacturer or to an authorized dealer. Transportation costs to or from the Manufacturer or Dealer are not covered under this warranty and remain the responsibility of the boat owner. The original purchaser shall pay expenses for labor incurred by BLUEWATER SPORTFISHING BOATS in the repair of any warranted product to the extent that such expenses for labor exceed the specified service rates of BLUEWATER SPORTFISHING BOATS, in effect at the date of receipt of the product by BLUEWATER SPORTFISHING BOATS.

Any parts, machinery, accessories, tanks, or equipment that are not manufactured by BLUEWATER SPORTFISHING BOATS are not warranted by BLUEWATER SPORTFISHING BOATS. The responsibility of BLUEWATER SPORTFISHING BOATS is limited to notifying suppliers of warranty claims concerning such items.

### **This limited warranty does not apply to:**

1. Gel coat, upholstery or other materials that are subject to a normal rate of wear by exposure to the elements or conditions of manufacture which BLUEWATER SPORTFISHING BOATS cannot control, including gelcoat cracking, crazing, fading, or blistering.
2. A BLUEWATER SPORTFISHING BOAT that has been powered or loaded more than the manufacturer's maximum Horsepower or Capacity recommendations.
3. A BLUEWATER SPORTFISHING BOAT that has been used in organized racing or commercial service.
4. A BLUEWATER SPORTFISHING BOAT that has been subject to misuse, negligence, high speed towing, or structural alterations of any kind.

5. A BLUEWATER SPORTFISHING BOAT that has been registered to anyone other than the original purchaser which has not been transferred in accordance with the terms and conditions outlined below.
6. A BLUEWATER SPORTFISHING BOAT for which no owners' registration card has been received by Bluewater Sportfishing Boats within ten (10) days of the original purchase.
7. Consequential or incidental damages or costs incurred by the original purchaser.
8. Haul out, transportation, shipping, or other charges which may be incurred in transporting and preparing the Bluewater Sportfishing Boats product for service. These charges shall be the responsibility of the original purchaser.

This warranty may be transferred ONE (1) time from the original purchaser to a second owner. To transfer the warranty, the purchaser must send to BLUEWATER SPORTFISHING BOATS a copy of the bill of sale noting the name and address of the new owner, a copy of the registration to the new owner showing the hull and engine number, and a check in the amount of \$250.00 to cover the cost of processing. The warranty transfer must be done within 30 days of the sale of the boat. Failure to follow this procedure will eliminate the transfer of Warranty to a second owner.

Warranty repairs are subject to the decision of BLUEWATER SPORTFISHING BOATS personnel which decisions shall be final.

BLUEWATER SPORTFISHING BOATS does not authorize any person, firm, or corporation to alter this limited warranty or create any other obligations relating to the product. This warranty gives you specific rights and you may also have other rights which vary from state to state. BLUEWATER SPORTFISHING BOATS reserves the right to change prices, specifications, and equipment without notice and without incurring any responsibility to apply such changes to previously manufactured boats.

## WARRANTY TRANSFER

The Bluewater Limited Hull Warranty can be transferred up to one additional assignment. The second assignment may be completed with the payment of a \$250 transfer fee made out to Bluewater Sportfishing Boats.
