MEETING MINUTES

June 5, 2025 at 8:30 a.m.

A public meeting of the Wabash River Regional Development Authority (RDA) Board was held on the above date and time. Members of the Board and staff participated in the meeting in person at the Excel Center of West Central Indiana's new location at 2800 Poplar Street, Suite 70, Terre Haute, IN.

- 1. **Call to Order**. Chair Jon Ford called the meeting to order and asked Meredith Osburn, CEO of Wabash Valley Goodwill and the Excel Center of West Central Indiana, to welcome all attendees and provide an update on the Excel Center (READI 2.0 project).
- 2. **Call of the Roll**: Present: Jon Ford (Vigo County); Jim Exline (Sullivan County); Josh Alsip (Clay County); Bill Rennels (Vermillion County).
- 3. - 5. **Regional Arts & Culture Plan Update (Designing Local)**: Designing Local gave an update on the Regional Arts & Culture Plan and took questions/comments from the board.

- 7. Vote to Approve Arts & Culture Planning Grant Pre-Commitment Letter for Compliance
 - 7.1. Josh Alsip motioned to approve. Jim Exline seconded. Motion passed unanimously.
- 8. IEDC Listening Session Recap (Rachel Leslie): RJL Solutions provided a brief recap on Secretary Adams' listening session in West Central Indiana. As part of Governor Mike Braun's administration, Secretary of Commerce David Adams conducted listening sessions and meetings across Indiana to gather feedback on the state's economic strategy.
- 9. READI 1.0 Update (RJL Solutions)
 - 9.1. Disbursement Update Disbursed \$9,374,414.34 to date, representing 48% of READI 1.0 funds. To access READI 2.0 funds, 65% of READI 1.0 must be expended.
 - 9.2. Projects that have not disbursed at least 50% of their allocated READI 1.0 funds by June 30, 2025 will be considered non-compliant.

Motion passes unanimously.
