***Re: People v. Cary Glenn Allen, Santa Barbara Superior Court Case No. 23CR03657***

Santa Barbara County District Attorney John T. Savrnoch announced today that charges have been filed against Cary Glenn Allen in connection with an incident that occurred on June 6, 2023, in the city of Santa Barbara.

Cary Glenn Allen has been charged with four felony counts - Aggravated Mayhem in violation of Penal Code section 205; Assault with a Deadly Weapon in violation of Penal Code section 245(a)(1) with a special allegation that Allen personally inflicted great bodily injury upon the victim pursuant to Penal Code section 12022.7(a); Leaving the Scene of an Accident Resulting in Serious Permanent Injury in violation of Vehicle Code section 20001(b)(2); and Evading an Officer Causing Injury in violation of Vehicle Code section 2800.3. Allen is also charged with two misdemeanors counts – Hit and Run Driving (resulting in property damage) in violation of Vehicle Code section 20002(a), and Domestic Violence Contempt of Court in violation of Penal Code section 166(c)(1).

Further, at the time of this incident, it is alleged, pursuant to Penal Code section 12022.1(b), that Allen was out on bail in Santa Barbara Superior Court case number 23CR01110. Allen is charged in that case with one felony count of Corporal Injury to a Spouse in violation of Penal Code section 273.5, and one misdemeanor count of Domestic Violence Contempt of Court in violation of Penal Code section 166(c)(1). As to the felony count, it is further alleged, pursuant to Penal Code section 273.5(f)(2), that Allen was previously convicted of Battery Upon a Spouse in Santa Barbara Superior Court case number 22CR07633. Allen was granted probation in that case on January 23, 2023.

If convicted of all charges and found in violation of probation, Allen faces a maximum sentence of 15 years to life in state prison.

Allen was arraigned on June 8, 2023. Allen pled not guilty to all charges and denied all special allegations. He is scheduled to appear for preliminary hearing setting in case numbers 23CR03657 and 23CR01110, and a probation violation hearing setting in case number 22CR07633 on Tuesday, June 13, 2023, in Department 11 of the Santa Barbara Superior Court. Senior Deputy District Attorney Megan Chanda is assigned to all matters.
