About Tarleton State University

Established on September 4, 1899, Tarleton State University (Tarleton State) offers the value of the Texas A&M University System with its own brand of personal attention, individual opportunities, history, and community. Tarleton State is an energetic, comprehensive Carnegie R2 Doctoral University with the elective Community Engagement classification and a member of the Association of Public and Land-grant Universities (APLU). The fastest-growing public institution in Texas, Tarleton State has experienced record enrollment growth and now serves approximately 21,000 students across multiple campuses and locations. The university offers 90 bachelor's, 44 master's, and six doctoral degree options through a broad array of academic colleges and programs. As a proud member of the Texas A&M University System, Tarleton State combines a student-focused mission with a rapidly expanding research enterprise and growing national prominence.

Position Summary

The Vice President for Research and Innovation (VPRI) serves as the University's Chief Research Officer and provides executive leadership for all research and innovation activities. This role is responsible for advancing the institution's research enterprise and fostering a culture of scholarship and innovation. The VPRI serves as a member of the President's Executive Team and collaborates with academic, industry, and government partners to expand research capacity, secure external funding, and enhance interdisciplinary initiatives.

Duties and Responsibilities

Executive Leadership & Strategy

- Provide strategic leadership and vision for the university's research, innovation, and economic development enterprise.
- Lead institutional planning efforts for research growth, sponsored programs, and technology transfer.
- Serve as a key advisor to the President on research priorities and emerging opportunities.

- Participate in executive decision-making regarding university planning, budgeting, and policy development.

Research Administration & Program Oversight

- Oversee the planning, coordination, and administration of all research and economic development initiatives.
- Lead the Division of Research, Innovation & Economic Development, including affiliated research centers and programs.
- Facilitate multidisciplinary research and campus-wide initiatives.
- Promote faculty and student research at both undergraduate and graduate levels.

Sponsored Programs & Funding

- Oversee grant development, submission, and negotiation of contracts for complex research initiatives.
- Ensure effective pre-award and post-award administration of sponsored programs.
- Expand external funding through federal, state, industry, and private sources.

Compliance & Regulatory Oversight

- Ensure compliance with federal, state, and system-level research regulations and policies.
- Oversee research compliance programs including IRB, IACUC, Conflict of Interest, Institutional Biosafety Committee, Research Misconduct, and Financial Conflict of Interest (FCOI).
- Coordinate with system and governmental entities on research-related requirements.

Innovation

- Lead initiatives that drive innovation and community engagement at regional and national levels.
- Partner with industry and community stakeholders to align research with workforce and economic needs.

Partnerships & External Relations

- Build and sustain strategic partnerships across academia, industry, and government.
- Serve as an ambassador for the university's research mission.
- Collaborate with peer institutions and research leaders to advance shared initiatives.

Required Education & Experience

- Doctoral degree in a relevant discipline.
- Minimum of 10 years of leadership experience in research administration and sponsored programs to include:
 - Demonstrated success in securing and managing externally funded research.
 - Experience leading cross-disciplinary research initiatives.
 - Experience in research ethics and compliance program oversight.

- Demonstrated strategic and visionary leadership with the ability to execute and drive organizational outcomes.

- Knowledge of research administration, including research ethics and compliance.

- Demonstrated commitment to promoting and advancing student engagement in research at all levels.

Institutional Profile

Tarleton State University is an energetic, comprehensive Carnegie R2 Doctoral University with the elective Community Engagement classification, and a member of the Association of Public and Land-grant Universities (APLU). The fastest-growing public institution in Texas, Tarleton State has experienced record enrollment increases in each of the last six years — increasing enrollment 48.58% since fall 2022, well above the state total for public institutions at 6.36%. With the success of our dual-enrollment program Tarleton State Today, we saw another all-time high enrollment in Fall 2025 at approximately 21,000 students. Our enrollment surges are proof that Tarleton State is quickly becoming one of the country's fastest growing comprehensive public universities in enrollment, research and national prominence.

The university offers 90 bachelor's, 44 master's, and six doctoral degree options. For their majors, students choose from 10 academic colleges — College of Agriculture and Natural Resources; College of Education; College of Liberal and Fine Arts; College of Science and Mathematics; Dr. Sam Pack College of Business; College of Leadership and Military Studies; Mayfield College of Engineering; College of Graduate Studies; Honors College; and the College of General and Applied Studies — as well as three colleges within the Division of Health Sciences, which includes the College of Nursing, College of Kinesiology and Sport Science, and the College of Health and Clinical Professions.

Tarleton State University is a proud member of the Texas A&M University System, and serves students on the main campus in Stephenville, its growing Fort Worth campus, in Waco, on the A&M RELLIS campus in Bryan, globally online, and through the Tarleton State Today dual-enrollment program.

NCAA Division I membership, rural healthcare education, and the ongoing expansion of our Fort Worth campus collectively position Tarleton State as a frontrunner for those aspiring to attain a university degree. Research Activities

Tarleton State supports outstanding research through 13 academic centers and institutes, including the Texas Center for Rural Research, Innovation & Economic Development, the Institute for Biotechnology, and the Texas Institute for Applied Environmental Research, which has generated more than \$88 million in research funding.

Since 2019, Tarleton State has increased research expenditures by 120%, helping Tarleton State earn the elevated designation of High Research Spending and Doctorate Production by the Carnegie Classification of Institutions of Higher Education. Tarleton State now operates as an EDA University Center, the only one in the region and one of just 73 nationwide. To bring new industrial collaboration and more research dollars to the state, a state-of-the-art Research and Economic Development Building was recently opened in 2024.

Student Body

Nearly 50% of Tarleton State students are first generation with no family tradition of seeking a post-secondary degree. Others are legacy students following their parents, grandparents and even great-grandparents as proud defenders of the purple and white.

Almost 40% of Tarleton State students report an ethnicity other than white and hail from all parts of Texas (230 counties), 50 states and over four dozen global countries. Nearly 80% receive some form of financial assistance, and almost 40% are Pell Grant eligible. They love the university — its people, its traditions, its commitment to student triumphs in and out of the classroom.

The Texas A&M System

Tarleton State University is proud to be part of The Texas A&M University System, one of the largest and most powerful systems of higher education in the nation. With a \$9.1 billion operating budget, 12 universities, a comprehensive health science center, eight state agencies, Texas A&M-Fort Worth, the RELLIS Campus and system office, the A&M System educates approximately 175,000 students and reaches millions more through service, research and outreach programs each year. With nearly \$1.6 billion in annual research expenditures, the A&M System fuels innovation, supports communities and drives Texas' economy forward.

Stephenville is located at the intersection of US-281, US-67 and US-377 and 25 miles south of IH-20 and 70 miles southwest of the Dallas / Fort Worth Metroplex. Stephenville is the retail center for a trade area population of approximately 80,000 Texans.

Agriculture is the leading industry, with Erath County in the top 10% in overall agriculture production and ranking No. 2 in milk production in the State of Texas. In addition to farmers and ranchers, Fortune 500 companies provide a strong manufacturing diversity to the economy. Stephenville serves as a regional medical and retail center for the area with many family-owned businesses thriving as they draw from a strong, diverse workforce, educational opportunities and family-oriented atmosphere.
