As I look back over this year, I'm drawn to the words of Romans 15:13: "May the God of hope fill you with all joy and peace as you trust in Him, so that you may overflow with hope by the power of the Holy Spirit." That verse captures the story of our past fiscal year—one marked by God's steady provision, your faithful generosity, and a mission that continues to overflow far beyond what any of us could accomplish alone.

This year, for 12.2 million people in 108 nations and territories, hope was multiplied.

It multiplied every time a mission team stepped into a community with medicine. It multiplied when local leaders received resources they had prayed for. It multiplied when children, families, clinics, and entire villages felt the tangible reminder that God sees them and has not forgotten their needs. Donations and prayers became seeds that God grew into healing, dignity, and opportunity.

The Lord blessed us with a busy fiscal year. We saw an increase in exports (up 25.8%), in the quantity of United States clinics served (up 15.7%), and the number of lives impacted in the United States (up 19.5%). Through partnership, what could have been "enough" became more than enough, allowing hope to multiply.

As we look ahead, we do so with renewed joy. We trust the same God who filled this year with abundance will continue to lead, provide, and empower the work ahead. Your partnership ensures that hope continues to multiply—not just once, but again and again, in ways only the Lord can measure.

Thank you for walking with us, praying with us, and believing in this mission. May the God of hope fill you anew, and may His hope overflow through us all as we serve faithfully in His name.

HUMAN TREATMENT VALUE FOR MEDICINES SHIPPED

Fiscal year 2025 was a record-breaking year. The human treatment value (HTV) of the medicines we shipped was **12,223,644**. Blessings International shipped **106,564,287** courses of medicine and vitamins to medical teams, clinics, and hospitals in 108 nations, including the United States. The chart on the opposite page details the estimation of lives impacted in each country.

HTV is our measurement for the number of lives affected by a product ordered through Blessings International. It is calculated from a formula that measures curative treatments and treatment days for all medicines shipped.

Curative treatments are defined as one full dosage of a treatment, regardless of how many individual pills/tablets/injections are required. For example, one course of antibiotics may require multiple tablets to treat one patient's infection over multiple days, but for HTV accounting purposes, it will be counted as only one treatment. Curative treatments include items such as antibiotics and antimalarials.


Treatment days are defined by the number of days a medicine is used. Total treatment days are the number of pharmaceutical dosages that are used to treat acute or chronic issues (including items such as analgesics, vitamins, antihypertensives, etc.) For example, if Blessings International ships a bottle of 500 vitamins and someone takes one multi-vitamin per day, that bottle will equal 500 treatment days.

Out of FY2025's total human treatment value, **8,970,518** were curative treatments and **97,593,769** were treatment days. With the medicines Blessings International shipped in FY2025, an estimated **12,223,644** people were treated.




The Evangelical Council of Financial Accountability accredits its members and holds them to high standards of accountability with respect to governance, financial management and stewardship/fundraising practices. Blessings International is proud to have achieved these standards and has been a member of ECFA since March of 1990.

For the record-breaking fiscal year of 2025, we continued to see strong post-pandemic financial performance. While we saw significant increases in US clinic partnerships and direct export shipments, we witnessed a slight downturn in short term mission shipments. We continue to utilize 100% of every donated dollar to support benevolence projects (detailed on pages 8 through 9).

Blessings International undergoes a financial audit each year by an independent public accounting firm. For further accountability, a separate firm prepares our IRS Form 990. The graphs below are based upon our 990. (Financial reports are available on our website at blessing.org/transparency.)


BLESSINGS INTERNATIONAL FISCAL YEAR 2025 FINANCIAL SNAPSHOT

PRODUCTION REPORT


Blessings International's production department is responsible for rebottling, repackaging, and relabeling pharmaceutical products sourced from manufacturers and other entities both domestically and internationally. Licensed by the U.S. Food and Drug Administration as a repackager, Blessings International is authorized to import medicines and medical supplies for export. This designation underscores the department's commitment to regulatory compliance and operational excellence.

15-Year Production Line Operational

In 2025, the production department proudly marked fifteen years of uninterrupted operation since the installation of its production line in 2010. Over this period, the team has continuously adapted the line to accommodate a wide range of bottle sizes and tablet shapes, ensuring alignment with the needs of medical mission teams. This year, the department achieved a 2.5% increase in productivity compared to the previous year, setting a new benchmark for operational performance. This accomplishment reflects the team's unwavering commitment to efficiency and excellence in every project. Through ongoing process enhancements and rigorous quality initiatives, the department continues to uphold the highest standards while advancing the organization's mission. Above all, the production team remains honored to contribute meaningfully to meeting medical needs worldwide.

BENEVOLENCE PROJECTS

Medicines for Orphans

\$28,800 DISTRIBUTED

The Medicines for Orphans fund provides for five orphanages in Haiti that are served by Blessings International's Haiti Orphanage Medical Support (HOMS) program. The program provides growth monitoring, medication for parasites, vitamin A, and anticonvulsants, as well as offering medical care by Zoom consultation for the children within the orphanages. In addition, the staff bring hope and an opportunity for the children to learn about faith and trust in God. Debi Lammert, the director of HOMS, shared, "The thing that stirs my heart the most during this prolonged, difficult season for Haiti is that the biggest thing we can bring is HOPE."

Malaria Medicine

\$4,824 DISTRIBUTED

According to the World Malaria Report 2025, 282 million cases of malaria were found last year in approximately eighty countries. In 2024, Nigeria, the Democratic Republic of Congo, Uganda, Ethiopia, and Mozambique accounted for almost half of the cases.

Malaria is preventable and curable, but in 2024, over 610,000 people died globally.

In response to the need for malaria medication, Blessings International provided free antimalarials to sixty-five teams going to thirty-three countries in FY2025. This impacted approximately 8,100 people in an effort to prevent early mortality of women, children, and families.

Emergency Disaster Relief

\$18,453 DISTRIBUTED

The Emergency Disaster Relief fund was able to help the victims of flooding, hurricanes, and natural disasters in FY2025. Families lost loved ones, employment, and access to their essential medicines. Blessings was pleased to be able to help our medical mission teams and families with medicines, wound care, and other medical equipment for chronic illnesses such as diabetes and hypertension.

USA Fund/Maternal Health

\$152,458 DISTRIBUTED

The USA clinic support provides essential prenatal vitamins, medicines, and medical supplies for United States charitable clinics, pharmacies, ministries, and pregnancy resource centers. Blessings is able to collaborate with free and

charitable clinics and maternal healthcare providers to provide care and treatment to those who are underserved or cannot afford health care.

Jenny Odom, the Executive Director for Pregnancy Test & Resource Center in Alabama, wrote, "Blessings has been a tremendous help to us and our patients. We serve primarily lower-income single moms who find themselves facing an unplanned pregnancy. Many of them struggle to meet basic needs for their families, and prenatal vitamins are not on their priority list. Medicines for Nations is our most flexible fund, and in FY2025, it enabled us to help twenty-six countries, including the United States. Through this support, orphans, families, young mothers, and the unborn receive vitamins, medicines, and medical supplies, bringing health and hope to each life and strengthening the community around them.

We provide every patient with free medications for all our mission trips! 
Ministry Support
