**CHANGES:** \*All Event Changes will result in a \$30.00 fee per change with no exceptions. Mandatory change fee for all changes, including name change, belt rank change, change of date of birth, event changes, and age division changes. All change requests must be submitted with a revised paper registration form with payment information and emailed to [uswc888@gmail.com](mailto:uswc888@gmail.com) **before** MARCH 6, 2026.

**AWARDS:** Beautiful quality Medals will be awarded to 1st, 2nd, and two 3rd places.

**SPECTATOR FEES:** \$20.00 Cash Only Infants - Free Valid all day ONLY on MARCH 14, 2026.

**MANDATORY UNIFORM REQUIREMENTS:** "Color Taekwondo Uniforms are allowed" at this tournament for non-sparring events only. Color Belt Sparring competitors must wear WT approved white uniforms in black or white V-neck. Black Belts MUST wear White World Taekwondo approved uniform with Black V Neck for sparring. Poomsae and weapons competitors may wear y-neck Poomsae uniforms approved by World Taekwondo. **No color uniforms are allowed in Olympic sparring competitions.**

**OLYMPIC SPARRING EQUIPMENT:** All sparring competitors must provide their own sparring gears & materials needed for their events. *Plastic Face Shield is required for ALL 14 years & Under Sparring divisions.* All Competitors MUST provide and wear shin-Insteps, first forearm pads, groin guards (male only, must be worn under uniform pants), clear or white mouth guards, chest protector, and head gear which matches chest guard color (unless white head gear is worn). DAEDO PSS will be used for Black Belt Sparring Competitions. Black Belt sparring competitors must bring own DAEDO socks.

**RULES:** Professional Taekwondo Federation, World Taekwondo, Kombat Taekwondo and Organizing Committee rules will govern this event with emphasis on fairness and traditional martial arts values.

**OLYMPIC SPARRING ROUNDS:** Best of 3 Rounds. All Ages & Belt levels - 1 minute round with 30 second rest period. *Tournament Chairman has the right to change the duration of rounds and official decisions without notices.*

**WEIGH - INS:** Weigh in will be done at the staging area during reporting time as stated on the event schedule on the day of the competitions for all sparring competitors.

**POOMSAE:** All Color Belt & Black Belt Poomsae competitors will compete in 1 Round of Compulsory Poomsae of their choice.

**BOARD BREAKING:** All boards must be purchased at the tournament venue for fairness. Each competitor must purchase their own board at the venue for \$5 each, cash only. Boards must be purchased at check in desks and will be distributed at ring side.

**DISTANCE BREAK** - One (1) Demo Board is Required. Winner will be the participant who jumps the farthest while breaking **one demo board** at the 1st or 2nd attempt without stepping on the foul line. A 2nd attempt will only be offered to competitors who step on the fault line or fail to break the board at the 1st attempt. Referees will serve as the board holders in all Distance Break Divisions.

**CREATIVE BREAK** - Ten (10) Demo Board is Required. Competitors will get 90 Seconds to set up complete their **10 demo board** break and clean up broken boards. One board per strike or kick. Maximum of two attempts on each board break. Boards must be held by athlete's coach; NO Board Holder's Passes Will Be Given. Foot and Hand Techniques Only. No assistive devices are permitted, including chairs and tables.

**COACH / MEDIA PASS:** All Coach & Media Passes can be registered online for \$100.00 each if paid by FEBRUARY 28, 2026. Registration for coach pass between MARCH 1 and MARCH 6, 2026 will be \$150. Coach or Media Passes can be purchased at the Venue for \$150.00, Cash Only. Please do NOT email or text to make Coaching Pass requests! Online registration ONLY.

## KOMBAT TAEKWONDO SPARRING ROUNDS:

**Minor League** - 2 Minutes One Round for 11 years & Under. 3 Minutes One Round for 12 years & over.

**Major League** - 3 Minutes One Round (18 years & over)

**KOMBAT TAEKWONDO UNIFORM:** V-neck or Cross, Black or White Taekwondo Uniforms are allowed.

**KOMBAT TAEKWONDO SPARRING EQUIPMENT:** All sparring competitors must provide their own sparring gears & materials needed for Kombat Taekwondo events.

**Minor League** (17 Years & Under) Mandatory Equipment - KT foot pads, KT gloves, \*KT head gear, groin guard for male, mouth piece, slip on shin and arm guards, and Taekwondo style chest guard.

**\*14 Years and Under:** Headgear with face shield is required.

**\*15 - 17 Years:** Official Kombat Taekwondo Head Gear Required.

**Major League** (18 Years & Over) Mandatory Equipment - KT foot pads, KT gloves, KT head gear, groin guard for male, mouth piece, slip on shin and arm guards, slip on elbow guards; no chest guard.

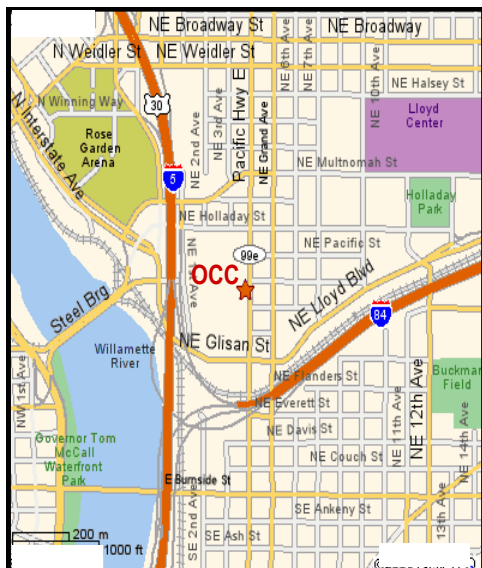
