

Proposed Solid Waste Fees

NOTICE IS HEREBY GIVEN that the Board of County Commissioners of Adams County, Idaho, will meet on Monday, September 14, 2026, at the hour of 11:00 am in the Jury Room in the Courthouse at Council, Idaho, for the purpose of increasing solid waste fees and the landfill tipping fee schedule.

According to Idaho Statute 63-1311A, the county shall give public notice of its intent to increase any fees.

1. The owner of any residence on January 01, 2027, and the owner of any residence in Adams County on the first day of each year thereafter shall pay an annual use fee of ONE HUNDRED SIXTY-FIVE (\$165.00) DOLLARS. Each commercial user within Adams County shall be assessed an annual use fee according to the volume of solid waste generated per the following schedule:
