

Public Services Reform (Scotland) Act 2010 Reporting Requirements 2024-2025

Overview

The Public Services Reform (Scotland) Act 2010 requires public bodies and bodies that carry out public functions, which includes the General Teaching Council for Scotland, to publish certain information relating to our expenditure.
