Removal with Consent Order

A Convenor has decided to issue you with this removal with consent order following your request for removal.

By signing below, I, [REDACTED], registration number [REDACTED], declare that:

1. I have had the opportunity to seek advice from an independent legal representative on the terms and content of this consent order.
2. I admit the below allegation(s) in full.

1 Between 5 December 2021 and 7 December 2021, whilst employed by [REDACTED] as a teacher at [REDACTED] the Teacher had in his possession indecent images of children on his mobile phone.

2 On 5 December 2021, whilst employed by [REDACTED] as a teacher at [REDACTED] the Teacher did take part in a conversation over the instant messaging application, KiK, with another Kik user in which the Teacher did:

(a) discussed indecent photos and videos of an 11-year-old child in the following terms:

- (i) State: 'Mmmmm what age is she?'
- (ii) state: 'Fuck, do you like to show her off';
- (iii) state: 'What kind of stuff do you have with her?';
- (iv) state 'No way that's so hot';
- (v) share: mega.nz/folder

(b) Share with another user on the instant messaging application, Kik, a link to a file sharing platform, Mega, commonly used to share images depicting child sexual abuse and exploitation which contained indecent images of children.

3 On 5 December 2021, whilst employed by [REDACTED] as a teacher at [REDACTED] the Teacher did carry out his conduct at allegations 1 and 2 whilst his [REDACTED] was present.

4 The Teacher's actions at allegations 1 and 2 were sexually motivated.

In light of the above it is alleged that the Teacher's fitness to teach is impaired and he is unfit to teach as a result of breaching Parts 1.3, 1.4, 1.6 and 2.3 of the General Teaching Council for Scotland's Code of Professionalism and Conduct 2012 (COPAC).

3. I waive my right to further adjudication proceedings.
4. I agree to the imposition of the below disposal order:

Removal

I understand that my name will be removed from the GTCS Register and that I will be prohibited from applying for restoration to that Register for a period of two years from the date of my name being removed from the Register of Teachers.

5. I understand that the content of this Panel Consideration Outcome will be made available to the public unless a Fitness to Teach Panel has decided that all or any part of it should be redacted.
