## Notes to the Tuition Schedule

This VET Course of study includes only units of competency from the AVI50222 Diploma of Aviation (Commercial Pilot Licence Aeroplane) & AVI50519 Diploma of Aviation (Instrument Rating). As this course is approved under the Higher Education Support Act 2003, eligible students' tuition fees may be deferred under the VET Student Loans scheme.

It is a requirement that only those who meet the requirements below can access a VET Student Loans for this course.

Those requirements are that a person must:

- Be an Australian Citizen
- Have an Unique Student Identifier - USI - application can be made at: [www.usi.gov.au](http://www.usi.gov.au)
- Australian Tax File Number – TFN (applicants wishing to access VSL only) – application can be made at [www.ato.gov.au/individuals/tax-file-number/](http://www.ato.gov.au/individuals/tax-file-number/)
- Pass the SFC Numeracy Assessment, Aptitude Test, Personality Profile – a pass in this assessment is required.
- Provide evidence of the Higher School Certificate (HSC) or AQ Certificate IV or higher

Additional requirements by SFC

- Practical Assessment – the SFC Flight Screening Assessment, Diploma Check Flight, or a PPL Skills Check must be completed to a satisfactory standard.
- Class 1 Medical - The list of approved Designated Aviation Medical Examiners (DAMEs) is available at [www.services.casa.gov.au/avmed/dame-search/](http://www.services.casa.gov.au/avmed/dame-search/)
- Aviation Security Identity Card (ASIC)– after the final screening interview you will be contacted to complete the ASIC application by Veritas. More information can be found at <https://sfc.asic.net.au/>
- Formal Screening Interview – this formal screening interview with SFC Enrolment Selection Committee must be completed and is an entry requirement.

Please note that the above does not include the following incidental fees, which must be covered by the student:

- Tuition fees and flight costs for remedial training outside the approved syllabus (repeat flight lessons and ground training) required to achieve competency. These are charged at the current price list rates as published on the SFC website.
- Any repeat attempt of any CASA exams required for your course. This includes repeating an exam that you fail to attend. These are charged at the current rates as detailed on the Aspeq website: <https://asla.aspegexams.com/Home/TermsAndConditions/>
- Any repeat attempt of any Flight tests required for your course. This includes both the cost of the flight sortie and the Testing officer's fees.
- Any additional textbooks you choose to purchase outside the issued textbooks or replacement books should you lose or misplace an issued text book.
- Uniform costs – you will need to supply your own as per the SFC dress code.
- Flight & booking cancellation fees – these fees assist in covering the overhead costs if a student does not attend or complete a scheduled flight/booking as per the attendance and cancellation policy.
- The cost of gaining and maintaining your CASA Class 1 pilots medical.
- The cost of gaining and maintaining your ASIC security clearance card.
