Salary sacrifice

Salary sacrifice lets your employees swap a portion of their salary for a non-cash benefit – like childcare, pension contributions, or a bike for commuting.

The amount each employee swaps is deducted directly from their salary and not subject to National Insurance. Employees get to keep those N.I savings. Some benefits also offer tax savings – and some can even save your business money!

Salary sacrifice: How it works

Some salary sacrifice benefits can save your organisation money.



Choosing salary sacrifice benefits with “employer savings” can reduce your Employer National Insurance Contributions (NIC). The more employees that sign up, the more you save.

The rate of Employer’s National Insurance Contributions (NIC) increased to 15% in April 2025.

Your responsibilities

As an employer:

- ▶ You must make sure every employee’s salary remains above the National Minimum Wage after salary sacrifice deductions
- ▶ Employees need to sign new employment contracts to acknowledge their adjusted salary
- ▶ You must report any taxable benefits to HMRC (either via payroll or P11D/P11D(b))



Adding salary sacrifice to your benefits offering can be a great way to offset the rise in NIC.





OTHER PROVIDERS
