A CASP (Crypto-Asset Service Provider) license allows crypto companies to operate legally across the EU under the new MiCA regulations.

CASP COMPLIANCE DEADLINES IN CYPRUS

- June 30, 2024 MiCA rules for assetreferenced tokens (ARTs) and emoney tokens (EMTs) take effect.
- December 30, 2024 Full MiCA compliance required for all CASPs, including licensing and operational requirements.
- July 1, 2026 CASPs operating before MiCA's enforcement must obtain authorization from CySEC or cease operations.

WHAT'S REQUIRED?



- ☐ Sender & recipient information must be collected and transmitted with every transaction.
- Record-keeping obligations CASPs must store transaction data for at least five years.
- Enhanced monitoring Transactions involving high-risk jurisdictions require additional due diligence.

The Travel Rule, based on FATF Recommendation 16, applies to all crypto transactions involving Cypriot CASPs.
