

SUSTAINABILITY POLICY

1 PURPOSE AND OBJECTIVES

This policy serves as a benchmark for management, managers and employees in their work to create memorable and sustainable mountain experiences with a focus on the guest.

The purpose of SkiStar's sustainability work is to manage sustainability risks and contribute to sustainable development.

The work is based on long-term goals in line with Agenda 2030 and the Paris Agreement and focuses on three areas: social sustainability, environmental sustainability and economic sustainability.

We work strategically in these areas together with guests, employees and partners to make SkiStar the sustainable choice, now and in the future.

2 EXTENT

The Sustainability policy includes SkiStar AB and the company's wholly-owned subsidiaries.

3 RESPONSIBILITY AND ORGANISATION

3.1 Strategic responsibility

Requirements and guidelines regarding the Group's work with sustainability issues are constantly altered. SkiStar's sustainability policy with associated sustainability goals for the entire operation must therefore be revised regularly and approved by the Board at least once a year.

SkiStar's Board of Directors is strategically responsible for sustainability in the company. After the CEO, SkiStar's sustainability manager is responsible for the Group's sustainability work and development.

3.2 Operational responsibility

To ensure progress in sustainability work and compliance with applicable policies and set targets, each business area manager and central function is responsible for integrating and driving sustainability issues within their respective areas. The Sustainability Manager supports and follows up on this work in close dialogue with the business areas and central functions.

3.3 Responsibility for each employee

Through continuous training, all SkiStar employees must understand how they in their business affect SkiStar's sustainability work and how each employee is a key in fulfilling the business's sustainability policy and achieving the business's sustainability goals. Annual sustainability training is provided to all company employees to ensure that sustainability issues are considered at all levels. Every employee is also expected to actively seek and absorb information.

4 SUSTAINABILITY RELATED RISKS

SkiStar is exposed to various risks related to the business. SkiStar annually identifies the risks that may prevent the company from achieving set goals and determines whether the risks are in line with the risk appetite. If necessary, measures are taken to avoid, reduce or follow up identified risks. The

purpose of risk management is to continuously assess and manage the risks that occur in the business and that it forms the basis for successful sustainability work. Identified sustainability risks are described in descending order below, with the risk with the highest probability and consequence coming first:

- **Limiting climate change**: Change in climate with warmer temperatures and changing weather/precipitation conditions affects operations and increases the risk of shorter/worse season with increased temperature and decreased amount of snow/increased amount of rain.
- **Adaptation to climate change**: Climate risks directly related to SkiStar's operations may include physical climate risks affecting the operation of the business, as well as the availability and prices of natural resources in the form of water, materials and energy.
- Loss of biodiversity: Risk that SkiStar contributes to unauthorised environmental impact through unauthorised emissions and impact on sensitive natural areas. Furthermore, there is a risk of restricting operations as SkiStar's operations may take place in nature conservation areas.
- **Limited water supply**: SkiStar has a water-intensive operation. Water availability for snow production is assessed on the basis of the water source, surrounding factors that may have a significant risk in the matter and the water licences that apply.
- Working in the value chain: SkiStar's operations involve risks relating to the working environment, corruption and human rights. These risks exist within the company, but also among suppliers and partners working on behalf of SkiStar. This risk can result in criminal offences but can also cause significant damage to SkiStar's business and brand.
- Affected communities. SkiStar needs to maintain good communication with the local community, including local and regional politicians and decision-makers, given the risk of disruption, e.g. in connection with development or new projects. This could negatively impact SkiStar's credibility and brand.

5 SUSTAINABILITY MEASURES

In order to reduce the impact of the above risks on SkiStar's operations, a strategy with long-term objectives has been developed.

We strive to develop our company together with guests, employees, stakeholders and partners with sustainability and responsible business in focus. SkiStar must be responsible and forward-thinking when it comes to the environment, human rights, labour law and anti-corruption. Sustainability is the core of business development and the way to create value for guests, employees, stakeholders and partners.

5.1 Public Health

At SkiStar, we work for an active lifestyle that contributes to increased well-being. Through collaborations and initiatives, we reach more people and contribute to active holiday experiences in nature all year round.

Through the product SkiStar offers we contribute to active leisure and good health effects. At SkiStar, we work actively to achieve our goal of getting more employees, guests, local residents and partners moving.

5.2 Climate

SkiStar is adapting its operations in line with the Paris Agreement's 1.5-degree target and has set a science-based goal of halving our greenhouse gas emissions by 2030. To achieve this, we are actively working to reduce our climate impact across our entire business through energy efficiency, transitioning to fossil-free transport and more circular solutions.

We strive to contribute beyond our own operations and therefore collaborate with suppliers, partners and guests to develop sustainable solutions that reduce climate impact throughout the value chain.

We continuously evaluate climate-related risks and opportunities and adapt our operations to meet changing conditions. This means, among other things, that we are climate-adapting our destinations and operations, investing in sustainable technology and developing our offerings for a more sustainable mountain life, both today and for future generations.

5.3 Biological diversity

We protect the unique ecosystems and wildlife of the mountains and work actively to preserve and strengthen biological diversity in the areas where we operate. Our operations must maintain high quality standards while minimising our impact on nature, water and biological diversity in the mountain environment.

In all exploitation and development of new land, we apply the hierarchy of consideration — we shall first avoid, then minimise and, as a last resort, compensate for any negative impact on biodiversity.

5.4 Water

Water is a critical natural resource and particularly important in the sensitive mountain environments where SkiStar operates. All our water use is governed by applicable legal requirements and water rights, which are strictly adhered to. We document all water extraction for up to ten years. Regulatory inspections are carried out regularly. SkiStar works continuously to improve the efficiency of snowmaking, build new water reservoirs and automate snow systems to reduce water consumption.

We also require our suppliers to manage water resources responsibly, as water is a scarce and critical resource in some countries. Consideration for water impact must be taken into account in production, delivery and other parts of the value chain.

5.5 Communities we influence

SkiStar operates in communities close to the mountains and takes responsibility for contributing to long-term sustainable development through dialogue, collaboration and good relations with municipalities, residents and other stakeholders. We contribute to job creation, local business development and activities for all ages, while working to minimise any negative impact we may have on the environment, society and culture.

6 INTERNATIONAL STANDARDS

SkiStar supports and complies with international sustainability standards, including the UN Global Goals, the UN Global Compact, the OECD Guidelines and the UN Guiding Principles on Business and Human Rights. We conduct regular human rights analyses and follow local sustainability programmes

7 REPORTING

SkiStar reports sustainability information annually in accordance with the Swedish Annual Accounts Act's rules on sustainability reporting To ensure transparent and relevant sustainability reporting, SkiStar complies with the reporting frameworks Corporate Sustainability Reporting Directive, EU Taxonomy, Science Based Targets and Task Force on Climate-related Financial Disclosures. SkiStar also reports its climate impact annually to CDP¹.

8 EXEPTIONS

SkiStar AB's Board of Directors shall decide on any deviations and exceptions to this policy.

9 FOLLOW-UP AND COMPLIANCE

Compliance with the Sustainability policy shall be regularly monitored by all managers, executives, Group management and the Sustainability manager and on a random basis by the company's auditors in connection with the annual review. If deviations from the policy are identified, this must be reported to the immediate manager, who in turn shall report the deviation to the Sustainability manager. Deviations can also be reported to the relevant person responsible via SkiStar Hub. The follow-up of compliance with the policy document shall be reported to the Group management and the Board of Directors through the Audit Committee in connection with the annual update of the policy document. However, should significant deviations be identified, such reporting shall be done without delay.
