## **Catholic Promise Family Agreement**

### **Program Summary**

The Catholic Promise program is a partnership between Catholic Central High School and families committed to Catholic education that provides a fixed, affordable annual tuition rate. The program is intended to make high-quality, faith-filled education more affordable for families.

### **How the Scholarship Works**

Any family registered and in good standing in a Catholic parish may apply for a flat annual tuition of \$6,000 per student (adjusted annually for inflation). The Catholic Promise Fund will cover every dollar of tuition beyond the \$6,000 family contribution.

#### **Family Criteria:**

- Verified family annual household incomes less than \$300,000, and transparent behavior related to requests regarding financial information
- Member in good standing at a Catholic parish through regular participation at worship and the stewardship of time, talent, and treasure
- Family service volunteer hours of at least 10 hours annually through events, activities, or programs at Catholic Central and/or parish church
- Attend school-wide liturgies, parent nights, and community events whenever possible to show visible support for the school

#### **Student Criteria:**

- A contributing member of the student body is achieved through participating in a minimum of one school activity outside of the classroom (athletics, music, theater, or other school-sponsored activity) per school year
- Commitment to completing a minimum of 20 hours of community service annually
- Annual GPA of 2.5 or higher
- Demonstrate acceptable character, showing consistent respect for authority and the school community
- Outstanding attendance record

## Annual Program Requirements & Applicant Agreement

Although the award requires annual renewal, the Catholic Promise program is dedicated to supporting committed families for the full four years of their student's high school education provided the students and families continue to meet the program standards and criteria as outlined above.

Applicants acknowledge and agree to the following:

- Income Determination - Annual household income is based on federal form 1040. The school may consider income and assets from parents, stepparents, or other guardians contributing to the student's support, regardless of custody arrangements.
- Income Verification - Applicants must submit their most recently filed federal tax return as the initial verification step and attest that it captures all income sources, including business income and distributions, trust distributions, family gifts, support, and inheritance. The scholarship committee reserves the right to request supplementary documentation, including business tax returns, asset declarations, financial statements, or other financial records.
- Application Deadlines - Applicants must comply with all published deadlines.
- Continued Eligibility - The school reserves the right to evaluate and determine continued scholarship eligibility at any time based on alignment with the covenant, school policies, or changes in family circumstances. The school may limit recipients based on capacity and program resources.
- Confidentiality - Program data, including personal family information, may be shared with program constituents for audit and oversight purposes. All information will be handled confidentially.
