The COVID-19 pandemic has had a devastating impact on Sacred Heart Minor Seminary (SHS) in Gulu, Northern Uganda and Archbishop Flynn Secondary School (AFSS) in Pader, Northern Uganda. Government-mandated school closings occurred in March 2020. Two grades (Senior 4 and Senior 6) students were admitted in October in order to prepare for the national exams scheduled for April 2021. Most families in Northern Uganda earn their living through day labor work - which was dramatically impacted by the total shutdown. No tuition or school fees were collected during the shutdown. Hope For Uganda (HFU) provided financial assistance to students who were unable to pay tuition and school fees while in session and provided support for teachers and staff when no tuition or fee were being collected in order to retain the talented staff. The HFU board raised the money needed to plant crops on 100 acres of the 262 acres of farm land purchased near AFSS in 2017. The following crops were grown and harvested in 2020: corn, edible beans, rice, sunflower (for cooking oil), cassava, and various garden vegetables. HFU has invested in equipment to be used on the AFSS farm including a tractor, plow and disc, and purchased two motorcycles for farm staff. HFU benefactor are raising funds for a basic road system for the farm and structures for crop processing and storage. Funds
