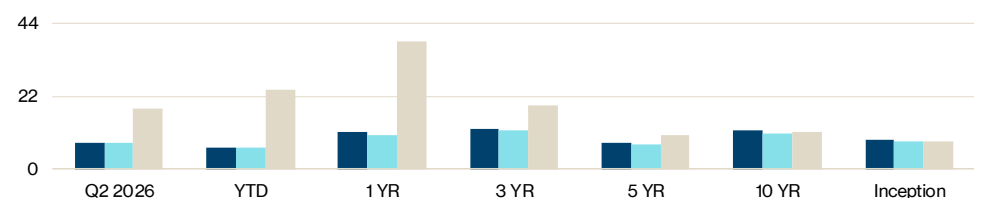

For this composite, RRAM defines a small to mid cap company as one whose market capitalization is less than \$20 B. RRAM selects securities from a universe of companies with a market capitalization at the time of initial purchase typically between \$250 MM and \$20 B, employing a value driven, bottom-up fundamental approach. **Benchmark Description:** The official benchmark for the composite is the Russell 2500 Value index.
