### **POLICIES AMENDMENT ADOPTION**

#### **Policy Amendments Review**

Discussion was held regarding policy amendments recommended by the WAHC Structure Workgroup.

#### **Correction of Scrivener's Errors**

Motion: To further amend scrivener's errors prior to the vote.

*Under 5 change "goals" to "contribution" where it appears*

*Under 6 change "in writing with local..." to "in writing..."*

*Under 8 change "or more local associations and all local requests..." to "or more local associations and those locals request..."*

Seconded and passed. **Motion, Seconded, Passed (MSP).**

#### **Adoption of Policy Amendments Items 1-5**

Motion: To adopt items 1-5 of the policy amendments as recommended by the WAHC Structure Workgroup. **MSP.**

#### **Committee and Leadership Role – Education Committees**

Motion: To add the Education Committees to the eligible committees for the Committee and Leadership Role portion of the scorecard.

Seconded but failed. **Motion seconded, not passed (MSNP).**

#### **Committee and Leadership Role – House Finance Committee**

Motion: To add the House Finance Committee to the eligible committees for the Committee and Leadership Role portion of the scorecard. **MSP.**

### **Adoption of Policy Amendments Items 7–13**

Motion: To adopt items 7–13 of the policy amendments as recommended by the WAHC Structure Workgroup. **MSP.**

### **Adoption of Policy Amendment Item 6**

- Motion: To adopt item 6 of the policy amendments as recommended by the WAHC Structure Workgroup. **MS.**
  - Motion to amend: Change the overall score needed for WAHC endorsement from 65% to 51%. **MSF.**
  - Motion to amend: Replace the scoring weights with 30% vote record, 10% leadership, 10% lobbyist, 50% member access. Seconded but failed. **MSF.**
  - Motion to amend: Replace the scoring weights with 55% vote record, 10% leadership, 10% lobbyist, 25% member access. **MSP.**
- **Item 6 adopted as amended.**

There was discussion to add court race standards to the policies and procedures. This will be worked on between meetings.

BIAW contract lobbyists provided an overview of the state of the legislature and looked ahead to the future November elections.
