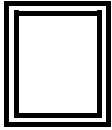

### **Shipping, Handling & Insurance**

Black Locust Lumber Global Enterprises Inc. ships materials FOB one or more of our plants/warehouses. The material is considered "shipped" and ownership passes from Black Locust Lumber Global Enterprises Inc. to Purchaser when the materials are:

- Released to a Common Carrier, or
- Picked up by Purchaser or Purchaser's agent directly from one of our plants/warehouses, or
- Shipped to Black Locust Lumber Global Enterprises Inc. "Ship to Storage" (see separate Storage and Insurance Agreement below).

In the event there is any shipping damage, first note the exception on the Delivery Receipt and do NOT sign for it as "Clear". Black Locust Lumber Global Enterprises Inc. has no recourse to the shipper and any damage will be the responsibility of the Purchaser.

In the case of international shipments Shipping, Handling & Insurance fees do NOT cover any import or custom duties levied upon Purchaser's import of these materials.

Please note that if the Ship To address on your signed Materials Bid is incorrect and the material needs to be delivered to a different address, additional charges will be billed to the Purchaser and a delay in Purchaser's receipt of the material will almost certainly result.

### **Partial Shipments**

Although Black Locust Lumber Global Enterprises Inc. ships most orders as a single shipment, on occasion Black Locust Lumber Global Enterprises Inc. makes partial shipments. In such cases, each partial shipment is considered a shipment in its own right (for purposes of payment needed seven business days - ten in the case of international shipments - prior to shipping, 7 day material acceptance period, etc.). In the event partial shipments are made for the Purchaser's convenience (and were not anticipated in the Materials Bid), additional Shipping, Handling & Insurance fees will apply and will be billed to the Purchaser.

### **Packaging**

Packaging methodology is dependent on the type and quantity of materials as well as the shipping method. Here are a few guidelines:

- Shipments originating in the United States typically require a forklift for unloading.
- Direct international shipments by container to you typically are NOT palletized (so as to conserve shipping and other costs) and therefore usually require hand unloading

### **Material Acceptance**

Please thoroughly inspect the material immediately upon its arrival. From the date the material arrives, Purchaser has seven days to inform Black Locust Lumber Global Enterprises Inc. of any discrepancy between the specifications of the material received and the specifications as shown on the Materials Bid. In the event Purchaser feels the material does not conform to specifications:

- Purchaser must, within this 7-day inspection period, notify Black Locust Lumber Global Enterprises Inc. by email (please send [sales@blpro.com](mailto:sales@blpro.com)) of any discrepancy.
  1. Please clearly explain in what way(s) the material does not conform to the specifications
  2. Please include pictures illustrating the problem
  3. Please refrain from installing, finishing, or in any way whatsoever altering the material as Black Locust Lumber Global Enterprises Inc. cannot accept any returns once the material has been altered
- Black Locust Lumber Global Enterprises Inc. Customer Service will promptly contact you in order to resolve the issue.
- If Black Locust Lumber Global Enterprises Inc. finds that the material shipped does not match the Materials Bid, Black Locust Lumber Global Enterprises Inc. may at its option:
  1. Replace or remill the non-conforming material (Purchaser will be asked to return the non-conforming material to Black Locust Lumber Global Enterprises Inc. with shipping paid by Black Locust Lumber Global Enterprises Inc.), or
  2. Credit Purchaser for the non-conforming material once received back at Black Locust Lumber Global Enterprises Inc. in a condition deemed acceptable to Black Locust Lumber Global Enterprises Inc. (Purchaser will be asked to return the non-conforming material to Black Locust Lumber Global Enterprises Inc. with shipping paid by Black Locust Lumber Global Enterprises Inc.).
- Note that Black Locust Lumber Global Enterprises Inc. is not able to accept return of material that conforms to the specifications of the Materials Bid.

### **Installation of Material**

Black Locust Lumber Global Enterprises Inc. cannot and does not take any responsibility for installation issues or problems resulting from installation of any Black Locust Lumber Global Enterprises Inc. materials. This means that Purchaser accepts full responsibility for such issues which can include, amongst other issues, lost labor, removal labor, reinstallation labor and/or cost of wasted materials for any and all reasons including, but not limited to the following:

- Failure to properly inspect and reject material prior to installation.

### **Add-Ons**

In the event Purchaser, having already received material from Black Locust Lumber Global Enterprises Inc. finds that the quantity is not sufficient to complete the installation:

- Such shortfall is the Purchaser's responsibility and not Black Locust Lumber Global Enterprises Inc..
  - In the event Purchaser wishes to purchase additional "Add-On" material from Black Locust Lumber Global Enterprises Inc. to complete the installation, please know that Black Locust Lumber Global Enterprises Inc. CANNOT assure Purchaser that Add-On material will blend in or look identical to the original material. Additionally, because of the need for extra set-up and other expenses on what may well be a small amount of Add-On material, the price per unit of the Add-On material may well be significantly higher than the original price. Additionally, standard lead-times will typically apply.
- For the above and other reasons, Purchaser is urged to initially order sufficient material - with a good allowance for waste - to avoid the need for Add-On material.

### **Modifications**

Please note that no one other than the CEO of Black Locust Lumber Global Enterprises Inc. is authorized to modify or amend this Materials Bid or make additional oral or written agreements or promises.

### **Resolution of Disputes**

If a dispute arises regarding any sale between Purchaser and Black Locust Lumber Global Enterprises Inc., the dispute shall be settled using licensed arbitration within Lewes, Delaware. The cost of the arbitrator shall be born equally by Purchaser and by Black Locust Lumber Global Enterprises Inc., but any other costs or expenses associated with arbitration shall be the sole responsibility of the individual or entity incurring the cost or expense.

### **Storage & Insurance agreement.**

As a service to you, Black Locust Lumber Global Enterprises Inc. will store and insure your Black Locust Lumber Global Enterprises Inc. materials for up to 6 months under the following terms and conditions:

#### **Storage and Identification**

Your Black Locust Lumber Global Enterprises Inc. materials will be stored directly on Black Locust Lumber Global Enterprises Inc. premises or in a similarly controlled storage space as determined by Black Locust Lumber Global Enterprises Inc.. Your materials will be clearly marked with identifying information.

#### **Ownership**

At the time Purchaser's materials are placed in storage, ownership passes to Purchaser and the materials become Purchaser's sole property.

#### **Insurance and Safe Keeping**

Black Locust Lumber Global Enterprises Inc. will take all reasonable precautions to keep Purchaser's materials safe from loss or damage. Purchaser's materials will be insured for the full purchase price paid for the materials, but such insurance is not to be construed as Black Locust Lumber Global Enterprises Inc. retaining any ownership over said materials.

#### **Liability**

In the event of loss or damage, Black Locust Lumber Global Enterprises Inc. will not be liable for any loss of profit, special, indirect, consequential, or other damages whatsoever.

#### **Release of Materials**

Upon proper authorization, Purchaser's materials will be released for shipment, provided that Purchaser has paid in full any remaining charges on Purchaser's account, including storage fees and all Shipping, Handling & Insurance fees.

#### **Billing**

Black Locust Lumber Global Enterprises Inc. requests that Purchaser pays any storage and insurance fees remaining on Purchaser's account. By wire transfer, please let Black Locust Lumber Global Enterprises Inc. know ahead of time.

#### **Storage and Insurance Fees**

- Materials worth less than \$25,000; \$150 per month or portion thereof
- Materials worth \$25,000 to \$50,000; \$250 per month or portion thereof
- Materials worth more than \$50,000; one-half of 1% of the purchase price per month or portion thereof (e.g. \$250,000 worth of materials incurs storage charges of \$1,250 per month)
- Minimum charge is for 3 months and will be charged when materials are first shipped to storage. Subsequent months will be automatically billed to Purchaser's credit card on file at the beginning of each month.

#### **Abandonment**

If Purchaser's materials remain in storage for more than 6 months, Black Locust Lumber Global Enterprises Inc. will make every effort to establish contact to arrange shipment or to extend this Storage and Insurance Agreement. If, after good-faith efforts to contact Purchaser, we are unsuccessful and provided that it has been at least 6 months since Black Locust Lumber Global Enterprises Inc. shipped said materials to storage, Black Locust Lumber Global Enterprises Inc. reserves the right to dispose of Purchaser's materials without any remuneration to Purchaser.

#### **Force Majeure**

Black Locust Lumber Global Enterprises Inc. shall not be responsible for cancellation or delay in delivery or performance resulting, in whole or in part, from causes beyond its reasonable control, including, but not limited to Acts of God, your acts, strikes or other labor disturbances regardless of whether or not BLL is capable of settling such strike or disturbance; facility conditions; temporary permanent facility closures; equipment failure; inability to obtain fuel, material, or parts, war, acts of terrorism, sabotage; riot; delay transportation; repairs to equipment; natural disasters; permanent facility closures; epidemics; floods; fires; action of governmental authorities (valid or invalid) severe weather conditions; accidents; explosions; failure of or inability obtain power, raw materials, suppliers, labor, equipment or transportation; a court or administrative injunction or order,; or any other contingency the nonoccurrence of which was a basic assumption on which this Agreement was made.

## **Sales Agreement**

*This Sales Agreement sets forth the terms and conditions under which Black Locust Lumber Global Enterprises Inc. materials are purchased.*

### **Material Specifications and Take-Offs**

Black Locust Lumber Global Enterprises Inc. wants material orders to be exactly correct as per Purchaser's requirements. Therefore, please be sure to verify all material specifications and take-offs including dimensions, grade, quantity, etc. Black Locust Lumber Global Enterprises Inc. does not take responsibility for the accuracy of this quotation in regards to Purchaser's specifications, grade, quantities, etc.

### **Imperial (English) and Metric Measurements**

Black Locust Lumber Global Enterprises Inc. materials are milled either to imperial (English) dimensions or to metric dimensions. Materials milled to metric dimensions are typically quoted on our Materials Bid in both imperial (English) and metric with metric being the overriding dimension.

### **Material Variability and Samples**

Black Locust wood is a natural material. Unlike many industrially manufactured goods, Black Locust Lumber Global Enterprises Inc. materials typically show unique intrinsic character which adds to the beauty of our woods. This character may include, amongst other things, a variety of colors, knots, texture, grain patterns, surface checking, oxide staining, as well as holes from insects, nails and bolts.

Black Locust Lumber Global Enterprises Inc. samples will be substantially similar to the materials Purchaser receives. However, due to the nature of wood in general and Black Locust wood in particular, samples typically CANNOT contain all the variations that will be present in the final material.

### **Order Placement, Lead Times and Expedite Fees**

An order is considered placed with Black Locust Lumber Global Enterprises Inc. once both the signed Materials Bid and Deposit are received by Black Locust Lumber Global Enterprises Inc.. Additionally, Black Locust Lumber Global Enterprises Inc. may choose to consider the order placed upon receipt of ONE or more of the following:

- Signed Materials Bid
- Purchaser's Purchase Order
- Deposit

The Materials Bid then in effect will be the controlling document for any order placed with Black Locust Lumber Global Enterprises Inc. regardless of whether or not a signed Materials Bid has been received by Black Locust Lumber Global Enterprises Inc.. Please note that once an order is placed, it is not cancellable by Purchaser. However, due to the nature of the wood (limited material supply, etc.) amongst other things, Black Locust Lumber Global Enterprises Inc. may elect not to accept an order or to cancel an already placed order.

Any lead times indicated on the Materials Bid are thoughtful estimates of the time it will take Black Locust Lumber Global Enterprises Inc. to prepare your order prior to shipment, but needs to be further confirmed to Purchaser as follows:

- Typically, within 48 hours of order placement, Black Locust Lumber Global Enterprises Inc. will email Purchaser an Order Acknowledgment confirming the order or declining to accept the order
- If Purchaser requires Black Locust Lumber Global Enterprises Inc. material sooner than the estimated ship date, please contact your Black Locust Lumber Global Enterprises Inc. Account Manager to see whether the order can be expedited. Expedite fees typically range from 15-30%.

### **Payment Terms**

Payment terms are as follows

- Orders of less than \$3,500 (aggregate of Materials, Taxes, and Shipping, Handling & Insurance) are payable 100% at the time of order. These orders are payable by check, wire transfer or by credit card.
  - o Orders expected to ship within two weeks are payable 100% at the time of order.
  - o Orders NOT shipping within two weeks are payable 50% at the time of order with the balance due 7 business days prior to shipment (ten business

days prior to shipment if shipment is international). If final payment is received by Black Locust Lumber Global Enterprises Inc. less than five days prior to the scheduled ship date, the shipment will likely be delayed. Palatalization fees TBD for complexity of the project.

- In the event (i) Purchaser decides that it no longer wishes to receive the materials it ordered and provides Black Locust Lumber Global Enterprises Inc. with notice of such prior to tendering final payment, or (ii) final payment is not received by Black Locust Lumber Global Enterprises Inc. within 30 days of its scheduled due date, Purchaser shall be responsible for and pay Black Locust Lumber Global Enterprises Inc. 80% of the aggregate of Materials, Taxes, and Shipping, Handling and Insurance (the "Materials Bid Amount") as liquidated damages. The parties agree that quantifying losses arising from Purchaser's decision or delay under this paragraph is inherently difficult insofar as such may impact Black Locust Lumber Global Enterprises Inc. ability to resell the materials or require it to store the materials for an extended period of time, and further stipulate that the agreed upon sum is not a penalty, but rather a reasonable measure of damages, based upon Black Locust Lumber Global Enterprises Inc. experience in the wood industry and given the nature of the losses that may result from such a decision or delay. Purchaser understands and agrees that its decision or delay under this paragraph will allow Black Locust Lumber Global Enterprises Inc. to retain the deposit held by it, demand and collect any further amounts needed to realize 80% of the Materials Bid Amount, and dispose of the materials Purchaser ordered as it sees fit without remuneration to the Purchaser. Purchaser also understands and agrees that collection of liquidated damages is not subject to the 'Resolution of Disputes' paragraph contained herein.
- The foregoing liquidated damages paragraph shall only apply in those situations where 100% of the Materials Bid Amount has not already been received by Black Locust Lumber Global Enterprises Inc. –
