End of Yardwaste Season

The 2025 Yard Waste collection will end the week of November 17th, 2025 Weather Permitting.

Acceptable Materials:

- Small Branches/Brush
- Grass Clippings
- Leaves
- Garden Waste (old flowers and weeds)



Unacceptable Materials:

- Dirt
- Rocks
- Rolls of Sod
- Tree Stumps



Minnesota state law prohibits mixing brush, tree or yard waste with your household garbage.

- Margarine, cottage cheese,
- cream cheese and other tubs and lids
- Laundry detergent bottles and jugs
- Clear berry and produce containers



Winter Placement



When the snow starts falling, please remember these guidelines to ensure collection on your service days.

Always have your cart(s) curbside the night before or no later than 6:00am to ensure collection.

It is your responsibility to make sure all snow is removed so that we can safely, and property service your home.

DIY Clean container

For odor:

Use all-purpose cleaner, baking soda, bleach, or vinegar and dish soap. Add cleaner to container carefully, scrub, and spray out with outdoor hose.

For stuck on bottom residue:

Pour hot soapy water in the container and let it soak for bottom residue.



Make sure that you let the trash can dry completely. If you don't then you will have created a new breeding ground for germs and smells, because of the moistness.

Natural Christmas trees are scheduled to be removed the weeks of January 5th, 2026 and January 12^{th,} 2026

Bows, decorations, ribbon, and wrapping paper should be bagged and placed in your trash container.
