MOORINGS & HARDSTANDING

Standard Berth Holders	£195 per metre LOA per annum
Larger Vessel Berth Holders	£258 per metre LOA per annum
Visitors Rate - minimum charge of 24 hrs	£1.50 per metre LOA per 24hrs, 24 hr increments
Tender (3m or less LOA)	£10 per month
Trailer/Cradle Storage	£20 per month

BOATYARD SERVICES*

(Services are paid for in advance)

Haul Out Using our Hoist & Pressure Wash (below waterline) <i>(our hoist can take up to 8 tonnes, 10m LOA & 3.25m beam)</i>	£23 per metre LOA
Launching Using our Hoist	£23 per metre LOA
Lift & Hold (haul out & launch the next day)	£25 per metre LOA
Mid-Season Lift & Pressure Wash on a tide (subject to availability)	£150
Pressure Wash	Labour Charge applies
Lifting Vessel on or off Transporter	Phone for a quote

Set down

Bilge Keel	£20
Into a Cradle	Labour Charge applies
Steel Cradle Hire	£40 per month
Boat Stands (often req'd for motor boats & lifting keel vessels)	£15 each, up to six months

Moving Boats

Collecting from a TSL Berth	£30
Collecting from a non TSL Berth	Plant & Operator charge applies

Masts

Mast Stepping & Un-stepping (Ketch & Yawl etc +50%)	£110 per mast
<i>These charges apply providing booms and sails are removed, electrics are disconnected and the bottle screws are not seized otherwise additional labour will be charged accordingly. Note: Fin-keeled yachts with masts up ashore require a metal cradle.</i>	
Mast Storage (must have own insurance)	Free of charge

Other

Plant & Operator – minimum charge of one hour	£65 per hour, ½ hour increments
Maintenance Posts (up to 24hrs)	£50 [TSL Berth Holders only]
Electricity Metered/Connection/Service Charge	£10 per month

* Services delivered outside of TSL Yard subject to a surcharge

LABOUR CHARGE

£45 per hour per person, minimum charge one hour, ½ hour increments

NOTES

- LOA = Length Over All. Boats are charged to the nearest 0.1 metres rounded up.
- Boats less than 6 metres will be charged at 6 metres.
- A £40 fee will be charged for each communication for overdue accounts and repeated administration.
- The Company has the sole right to determine whether or not a boat falls under the "Larger Vessel" licence.
- The Company reserves the right to make additional charges for multihull vessels ashore and/or afloat of + 25%.
- £400 deposit in advance required for all new customers.
