# Deaf Facility Enrolment Policy

## Background

Brighton Primary School provides educational programs for students who are Deaf and Hard of Hearing (DHH). Our Deaf Facility offers a specialised program designed to provide an inclusive education for DHH students. This facility is equipped with state-of-the-art resources and staffed by experienced professionals – including Teachers of the Deaf, learning enhancement teachers and learning support aides.

By law in Victoria all children from the age of 6 up until they turn 17 years must be enrolled at a registered school or registered for home schooling unless they have a reasonable excuse. School participation maximises life opportunities for children and young people by providing them with a comprehensive educational program and access to support networks. It also helps to develop important skills, knowledge and values that set them up for further learning and active participation in their local community.

Local government schools with a Deaf Facility provide specialised educational support for deaf and hard of hearing students, including communication and technological support needs. Additionally, these schools employ qualified Teachers of the Deaf and support staff. Schools with a Deaf Facility campus also have enrolment policies that allow them to prioritise enrolment of students with disability who live outside the school zone, provided they meet specialist enrolment criteria.

## Purpose

The purpose of this policy is to specify the enrolment criteria for students seeking enrolment at Brighton Primary School and the evidence required to support applications for enrolment.

## Scope

Brighton Primary School is a designated neighbourhood school with a designated neighbourhood zone (school zone).

This policy applies to:

- students seeking enrolment who live within or outside the school zone; and
- deaf and hard of hearing students who live outside the zone and seek priority enrolment under the specialist enrolment criteria.

## Enrolment Criteria

School aged students who reside permanently within the school zone are guaranteed a place at Brighton Primary School.

School aged students may also apply for a place at Brighton Primary School if they live outside the school zone. These students should be enrolled if there is sufficient accommodation at the school, and if the request for enrolment aligns with the school's enrolment management implementation plan (if one is in place).

## Priority Order of Placement

If there is not sufficient accommodation to accept all applications from students living outside the zone, Brighton Primary School will prioritise applications in line with their enrolment management implementation plan (if one is in place). In the absence of an enrolment management implementation plan, Brighton Primary School will manage enrolment applications in accordance with the following priority order of placement:

1. Students with a sibling at the same permanent address who are attending the school at the same time.

2. Students who meet the specialist enrolment criteria outlined below.
3. All other students in order of closeness of their home to the school.

If there is not sufficient accommodation to accept all applications from students who meet the specialist enrolment criteria (once in-zone enrolments and out-of-zone sibling enrolments have been confirmed), these applications will be prioritised in order of closeness of their home to the school.

### Specialist enrolment criteria

The following specialist enrolment criteria have been specified and approved by the Deputy Secretary, Schools and Regional Services (as the Minister's delegate), under section 2.2.16(b) of the Education and Training Reform Act 2006 (Vic).

Students seeking priority enrolment under the specialist enrolment criteria must have:

1. A bilateral sensori-neural hearing loss that is moderate/severe/profound  
*and*
2. The student requires intervention or assistance to communicate.

### Evidence and supporting information requirements for the specialist enrolment criteria

To support a student's application for enrolment, the following evidence and supporting information must be provided:

#### **Criterion 1 - A bilateral sensori-neural hearing loss that is moderate/severe/profound.**

- A current signed audiogram and written statement describing the type of hearing loss from a qualified audiologist (dated within the past 12 months).

OR

- A signed statement from an audiologist or professional from a cochlear implant clinic confirming the student has cochlear implant/s (no timeframe requirements).

Nb. For students with a cochlear implant in one ear only, a signed audiogram and written statement describing the hearing loss from a qualified audiologist (dated within the past 12 months) is required to verify a moderate/severe/profound sensori-neural hearing loss in the non-implanted ear.

#### **Criterion 2 - The student requires intervention or assistance to communicate.**

- Evidence from a relevant professional that the student requires intervention or assistance to communicate.

The department's regional offices play a role in helping schools with enrolment processes.

**NOTE: Enrolment applications may not be successful if the requested documentation is not provided or is invalid.**

### Verification of permanent address

When assessing enrolment applications under the priority order of placement, Brighton Primary School may ask for supporting documentation to assist them in verifying a student's permanent address. For more information, see [Determining permanent residence](#).

### Enrolment on compassionate grounds

In exceptional circumstances, a student may be enrolled on compassionate grounds. This is an overarching consideration and does not form part of the priority order of placement. Further information can be found at ['Exceptional circumstances - compassionate grounds'](#).

## Appeal Process

Parents or carers can appeal an enrolment decision by lodging a written appeal with the principal.

If this appeal is unsuccessful and parents or carers are not satisfied that their appeal has been adequately considered, they may write to the South-East Victoria Regional Director. Further information on appeals can be found at [Appealing enrolment decisions](#).
