Soil health stands as a strategic pillar within Silal's R&D and farming team, with consistent efforts aimed at elevating soil quality and boosting productivity. Silal is working towards reducing usage of chemical pesticides by 2% at its greenhouses year on year compared to 2023 baseline year. As part of its commitment towards sustainable agriculture practices, Silal has set a target to train 300+ farmers in 2024.

Recognizing the significance of responsible water management practices, Silal is committed to preserving this invaluable resource while optimizing agricultural operations. Through strategic investments in efficient water management techniques such as precision irrigation and water recycling, Silal strives to minimize water usage.

## 4.1.b. Environmental Stewardship and Resource Conservation

Silal is committed to continual refinement of waste management protocols, enhance emissions control strategies, and contribute to energy conservation practices. Silal aims to achieve year on year 2% reduction in GHG emissions per unit of revenue from a 2023 baseline year. Silal has a target to cap fresh produce waste at 9% by 2025. Silal is also working towards achieving its 0 waste to landfill target by 2025.
