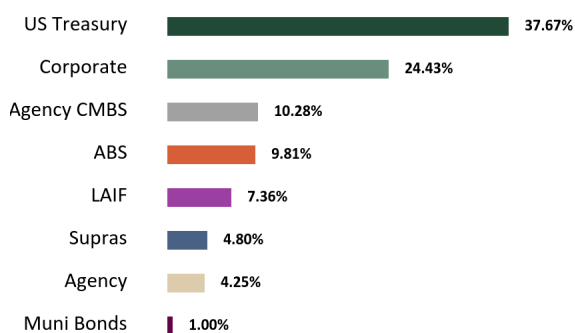

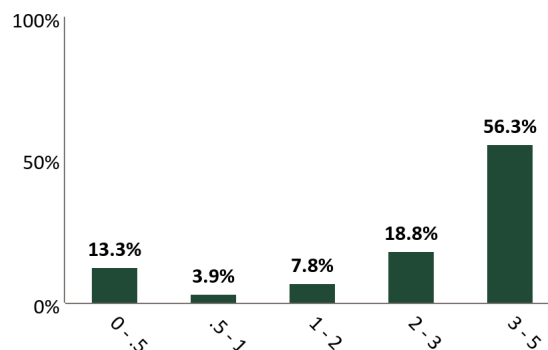

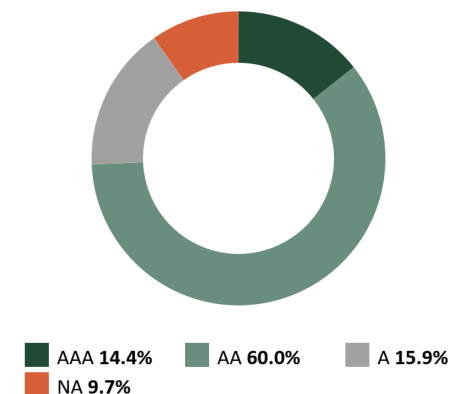
Sector Allocation

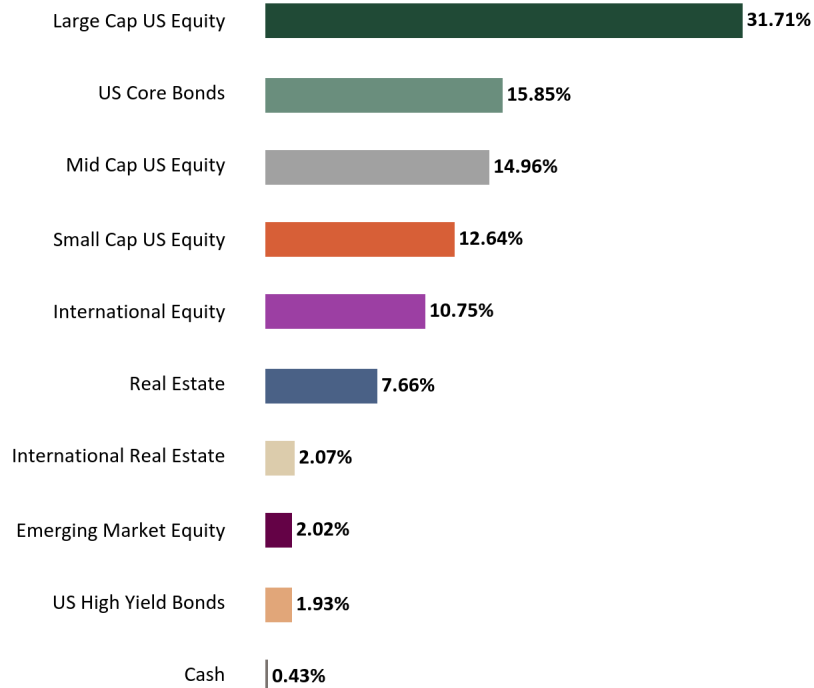
