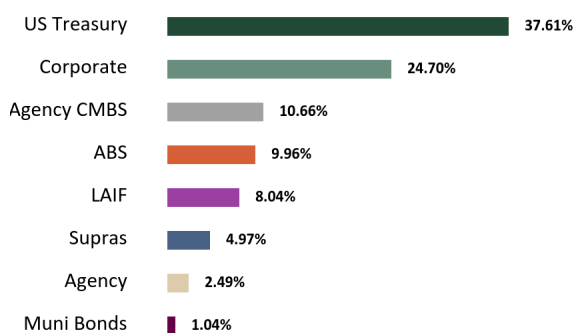

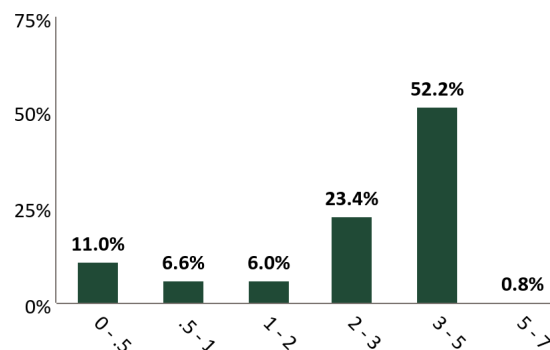

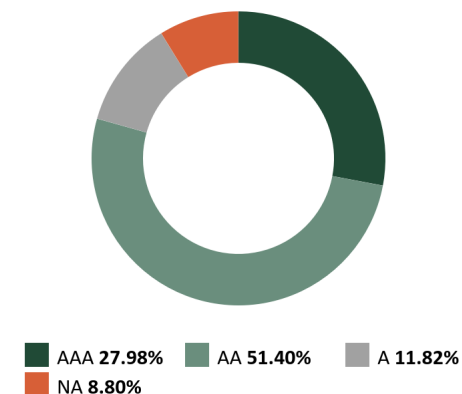
Sector Allocation

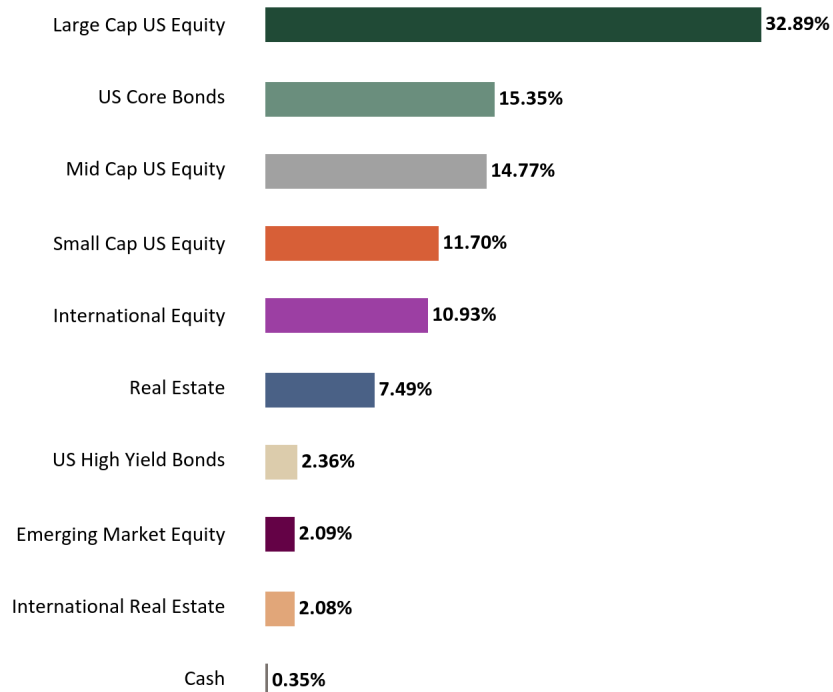
