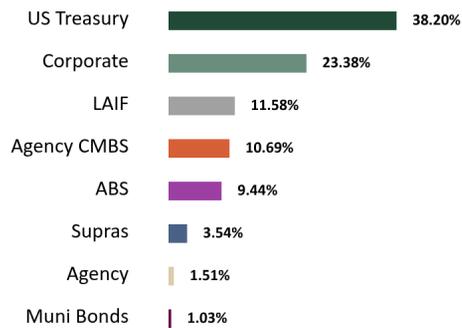

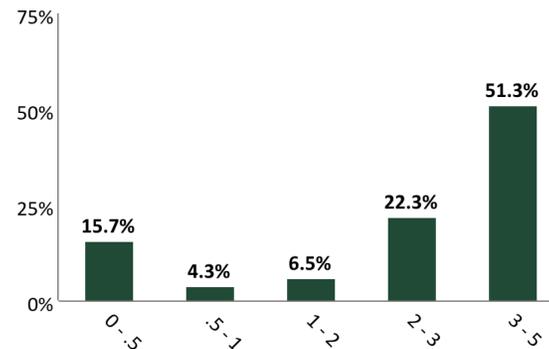

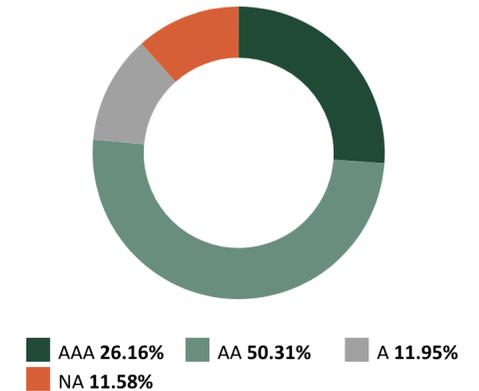
Sector Allocation

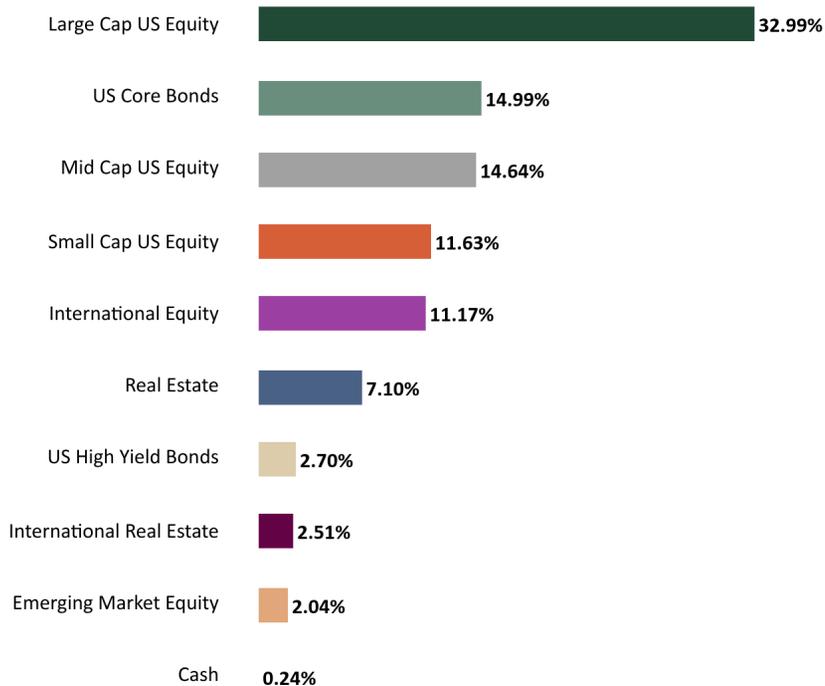
