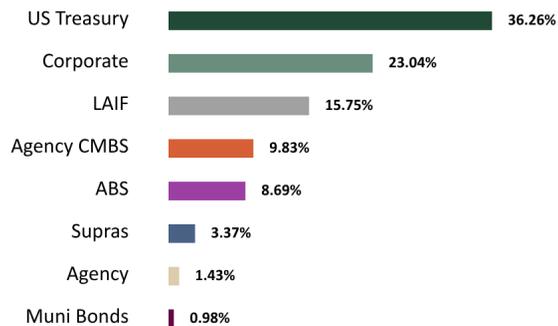

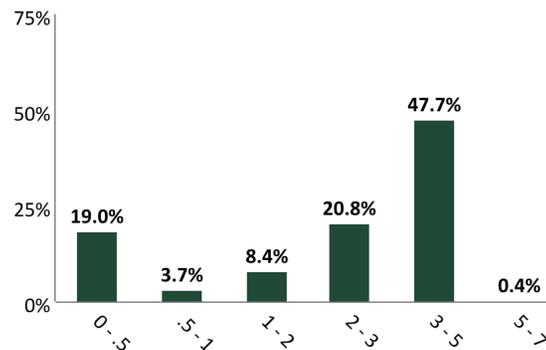

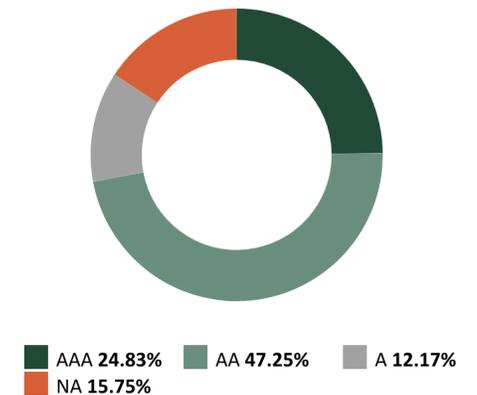
Sector Allocation

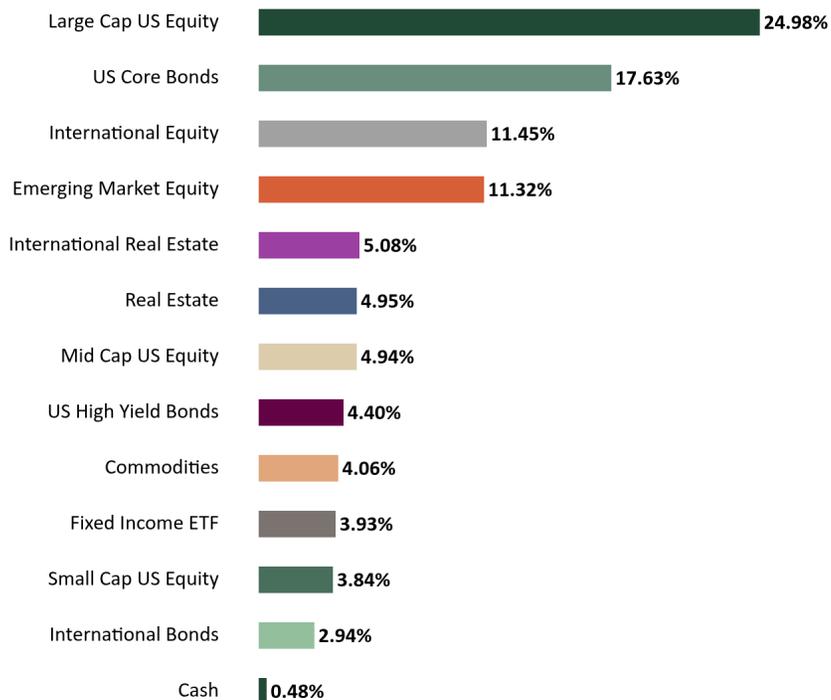
