PUBLIC NOTICE IS HEREBY GIVEN that the City of Corona, California, will publish the draft 2025-2026 Consolidated Annual Performance and Evaluation Report (CAPER) for a 15-day public review and comment period. The CAPER is an annual progress report to the U.S. Department of Housing and Urban Development (HUD) reflecting the accomplishments of the Community Development Block Grant (CDBG) and HOME Investment Partnerships (HOME) programs for funds expended during fiscal year 2025-2026 in relationship to the housing and community development priority needs identified in the 2025-2029 Consolidated Plan and the 2025-2026 Annual Action Plan.

A copy of the draft CAPER will be available for public review during business hours starting Monday, August 31, 2026 and ending Wednesday, September 16, 2026 at the City of Corona's City Clerk's Office located at 400 S. Vicentia Avenue, Corona. The draft CAPER may also be reviewed at the Corona Public Library, Reference Desk, located at 650 S. Main Street, Corona, or online at www.CoronaCA.gov/cdbg. Residents are encouraged to review the report and share their feedback on the City's performance as well as any emerging housing and community development needs, strategies for affirmatively furthering fair housing, proposed activities in the Action Plan. The public review and comment period will conclude at 4:00 p.m. on September 16, 2026.
