

## OFFICIAL RULES:

BY ENTERING THE DINE ABOUT PHOTO CONTEST, ENTRANTS AGREE TO THE TERMS AND CONDITIONS.

**SPONSOR/ADMINISTRATOR:** DINE ABOUT™ is a privately sponsored event.

**ELIGIBILITY:** The DINE ABOUT Organizer, their respective immediate families (parent, child, sibling, or spouse), and/or household members and any other persons or entities associated with the Program are ineligible to enter or win.

**TIMING:** DINE ABOUT will be defined by the following time periods: (1) The Submission Period (“Submission Period”)—Entries will be accepted between 00:00 a.m. PST on January 17, 2026, through 11:59 p.m. PST on Feb 5, 2022. (2) Prize Period (“Awarded Period”) will run January 20, 2026, through February 7, 2026.

## HOW TO ENTER THE PROGRAM:

Eligible Entrants can enter the Program by

- Post a photo of your dining experience on your Instagram,
- tag the establishment,
- add #DineAbout2026

\*If a prospective Entrant chooses to enter the Program through Instagram, they must publicly post the image along with the Program’s custom hashtag, #DineAbout2026, and the name of the DINE ABOUT participating restaurant. The entry will not be acknowledged unless the post is public, includes the specified hashtag (#DineAbout2026), and the name of the restaurant. Please check your account’s privacy settings before Entry.

**USAGE RIGHTS:** DINE ABOUT respects photographers' rights and does not claim copyright over images submitted to this contest; you, the author, retain full copyright in each entry. Whenever your image is published by DINE ABOUT, you will be credited.

By entering this contest, you agree that any images you submit may be used by DINE ABOUT solely for marketing and promotional purposes of DINE ABOUT and no other purpose. These uses include displaying the entries on the contest website, promotion of the contest, promoting DINE ABOUT and the photographers, cropping and resizing the image as necessary to fit predefined formats for the competition.
