Acceptance of Terms

Welcome to Saiit, operated by Keoce SASU, a company registered in France. By accessing or using the Saiit mobile application (the “App” or the “Software”), you agree to comply with and be bound by these Terms of Service (“Terms”).

These Terms govern your rights and obligations regarding the use of the App and service (both collectively referred to as the “Service”) on the Internet or in cellular media. If you do not agree to these Terms, please do not use the App.

Description of Service

Saiit is a real-time information sharing and community engagement platform that allows users to post and discover local public events, sightings, and updates.

Software License

Saiit hereby grants you a non-exclusive, time-limited, non-transferable, non-sublicensable, revocable license to use the Service for non-commercial purposes, subject to these Terms.

User Accounts

Individual Users

- **Registration:** To use certain features of the App, you may be required to create an account and provide accurate and complete information.
- **Account Security:** You are responsible for maintaining the confidentiality of your account credentials and for all activities that occur under your account.

Business Users

- **Verification:** Businesses are required to verify their account details to use the App.
- **Account Security:** Business account holders are responsible for maintaining the confidentiality of their account credentials and for all activities that occur under their account.

User Responsibilities

- **Compliance with Laws:** You agree to comply with all applicable laws, rules, and regulations while using the App.
- **Your Content:** You assume sole responsibility for any Content you post and you alone are liable for the consequences when you post Content.

By submitting Content to Saiit, you grant Saiit, Keoce SASU, and the users of the Service a worldwide, perpetual, royalty-free license to use, display, and distribute the Content.

Privacy Policy

Your use of the App is also governed by our Privacy Policy.

Examination of Content

Saiit reserves the right to review, edit, or delete any content that does not comply with these Terms.

Saiit does not guarantee that all Content will be published or remain published for any period of time.

Termination of Service

Keoce SASU reserves the right to suspend or terminate your access to the App at any time for violations of these Terms.

Intellectual Property Rights

All content, features, functionality, trademarks, logos, maps, and software are the exclusive property of Keoce SASU and protected by applicable copyright laws.

Apple

Apple bears no obligations regarding maintenance or support of the Service.

You represent that you are not located in a country subject to embargoes or restrictions by the U.S. Government or European Union.
