At each regular meeting, the board will set aside time to afford the general public an opportunity to speak to the board on matters both listed and not listed on the board's agenda. Speakers will be recognized on a first come-first served basis as indicated on the sign in sheet. A speaker will be given up to 3 minutes to address the board. Per Texas Government Code Chapter 551.007, the board may not prohibit public criticism of Universal Academy or the LTTS Charter School, Inc. board, including criticism of any act, omission, policy, procedure, program, or service. This does not apply to public criticism that is otherwise prohibited by law. The board is prohibited from publicly commenting on or acting on non-agenda items; however, the presiding officer may refer the non-agenda item(s) to the superintendent for further review. If there are no public communications or comments, the Board will proceed to other business.

When necessary for effective meeting management or to accommodate large numbers of individuals wishing to address the Board, the presiding officer may make adjustments to public comment procedures, including adjusting when public comment will occur during the meeting, reordering agenda items, deferring agenda items to a later meeting, providing expanded opportunity for public comment, or adjusting the time allotted to each speaker. However, no individual speaking on an agenda item shall be given less than one minute to make comments.
