You can also fill out the application page in this document, sign it, and mail or scan-and-e-mail it to us. You'll receive a confirmation email or letter within a few days, and you'll receive the show information packet about 2-3 weeks prior to the show.

Acceptance process: A letter/email indicating the status of this contract will be sent once the contract is received. The letter will state whether the contract has been <u>accepted</u>, <u>declined</u>, or is *on-hold* (*pending*) while we complete the show floor plan. If placed in a "pending" status, you will receive an accepted or declined notice of this contact at least 21 days before the show. This constitutes an agreement between parties and cannot be orally modified. Modifications can only be made by written agreement.

Merchandise sales: Occasionally, clubs will ask if they can sell items at the show, often as a fundraiser for the club. This is permissible, but there are restrictions. If a club is selling specific club branded items, like a shirt with the club's name, or a club car, then there is no fee to do sell at the show. If the club is selling general merchandise, even if the items were donated, the club will need to purchase selling space. This is to be fair to the other dealers. If a club were to receive donated items, or get the space for free or discounted, they would be able to sell the items at a lower price, since they have lower costs. To keep things fair for all the exhibitors selling items, regular selling fees will apply. If you have questions regarding selling at a show, please ask.

Standard Honorarium

Display layouts will be paid a standard honorarium based on square footage and will be as follows:

\$50.00 Less than 100 ft of actual layout \$100.00 101 to 499 ft of actual layout \$150.00 500 or more ft of actual layout

You may request a non-standard honorarium. Please be aware we will give first preference to those who do not require an honorarium, then second preference to those who request the standard honorarium and lastly the non-standard honorarium requests. Odds are, if you are asking for something other than the standard honorarium, you will not be accepted except in rare circumstances.

Workshop presenters will be paid a \$15.00 standard honorarium per workshop.



<u>World's Greatest Hobby on Tour:</u> In 2025, I updated and streamlined the show format, and it will remain the same for 2026. The show will now look like a show within a show. The area at the very front of the hall will be designated for the traditional World's Greatest Hobby on Tour style of show. This will have the look and feel of past World's Greatest Hobby on Tour events with pipe and drape, skirted tables, etc. and is where the manufactures and dealers wishing to be in that section will be placed.

The remainder of the hall will have the look and feel of our traditional Great

Train Shows. Standard tables, as well as our 3 table booths will be available for those selling, that do not need the options of the WGH portion of the show. Because the area will not be separated, the public will be able to flow throughout the entire show, seeing all of the manufactures, sellers, layouts and attractions, and will allow us to bundle that into a very attractive package to help drive attendance.

Terms & Conditions

The term "EXHIBITOR" applies to clubs, dealers, organizations or individuals(s) presenting exhibits, displays or demonstrations related to trains and train-related hobbies. The EXHIBITOR hereby agrees to the following regulations, which are listed in this EXHIBITOR contract and to any amendments, which may be established in consideration for the space provided by Great Train Show, World's Greatest Hobby on Tour and Giant Shows Inc.

EXHIBITOR agrees to keep his/her display operational to the public, to not remove any items from his/her display for the purpose of packing during the public show hours. Violation of this rule will lead to exclusion from future shows and may result in a claim for damages to the appearance of the show. EXHIBITOR releases Giant Shows, Inc, Great Train Show and World's Greatest Hobby on Tour from all claims arising from EXHIBITORS show occupancy, including but not limited to loss, theft, damage, destruction or injury to EXHIBITOR'S business or EXHIBITOR personnel. EXHIBITOR releases Giant Shows, Inc, Great Train Show and World's Greatest Hobby on Tour from all claims arising out of Giant Shows, Inc, Great Train Show and World's Greatest Hobby on Tour's failure to provide space, removal of exhibit, or failure to hold the show.

EXHIBITOR understands Great Train Show, World's Greatest Hobby on Tour and Giant Shows Inc., assume no responsibility for any EXHIBITOR property or for safety at the show. EXHIBITOR agrees to hold harmless Great Train Show, World's Greatest Hobby on Tour and Giant Shows Inc., its exhibition centers, and contractors for any and all actions that may occur involving the show. EXHIBITOR agrees to indemnify Great Train Show, World's Greatest Hobby on Tour and Giant Shows Inc., for any liability that may be caused by or related to their participation. This includes but is not limited to any liability caused by people EXHIBITOR provides EXHIBITOR badges to, people EXHIBITOR invites to the show, and any liability that may be caused by the EXHIBITOR'S actions.

Great Train Show, World's Greatest Hobby on Tour and Giant Shows Inc., retains the right to reject, eject or prohibit any product or exhibit in whole or in part or to reject, or eject an EXHIBITOR or his/her representative(s) with or without giving cause. If cause is not given, Great Train Show, World's Greatest Hobby on Tour and Giant Shows Inc., liability shall not exceed the return to the EXHIBITOR the amount of the license fee unearned at the time of ejection. EXHIBITOR agrees to collect and remit sales and use tax in accordance with governmental regulations. EXHIBITOR acknowledges that Great Train Show, World's Greatest Hobby on Tour and Giant Shows Inc., furnishes the name of each EXHIBITOR to the state or governmental unit(s) as legally required. Any controversy or claim arising out of or relating to this license, or the breach thereof, shall be settled by arbitration in accordance with the Commercial Arbitration Rules of the American Arbitration Association, and judgment upon the award rendered by the Arbitrator(s) may be entered in any court having jurisdiction thereof. It is agreed that such arbitration would occur near our offices in Illinois.
