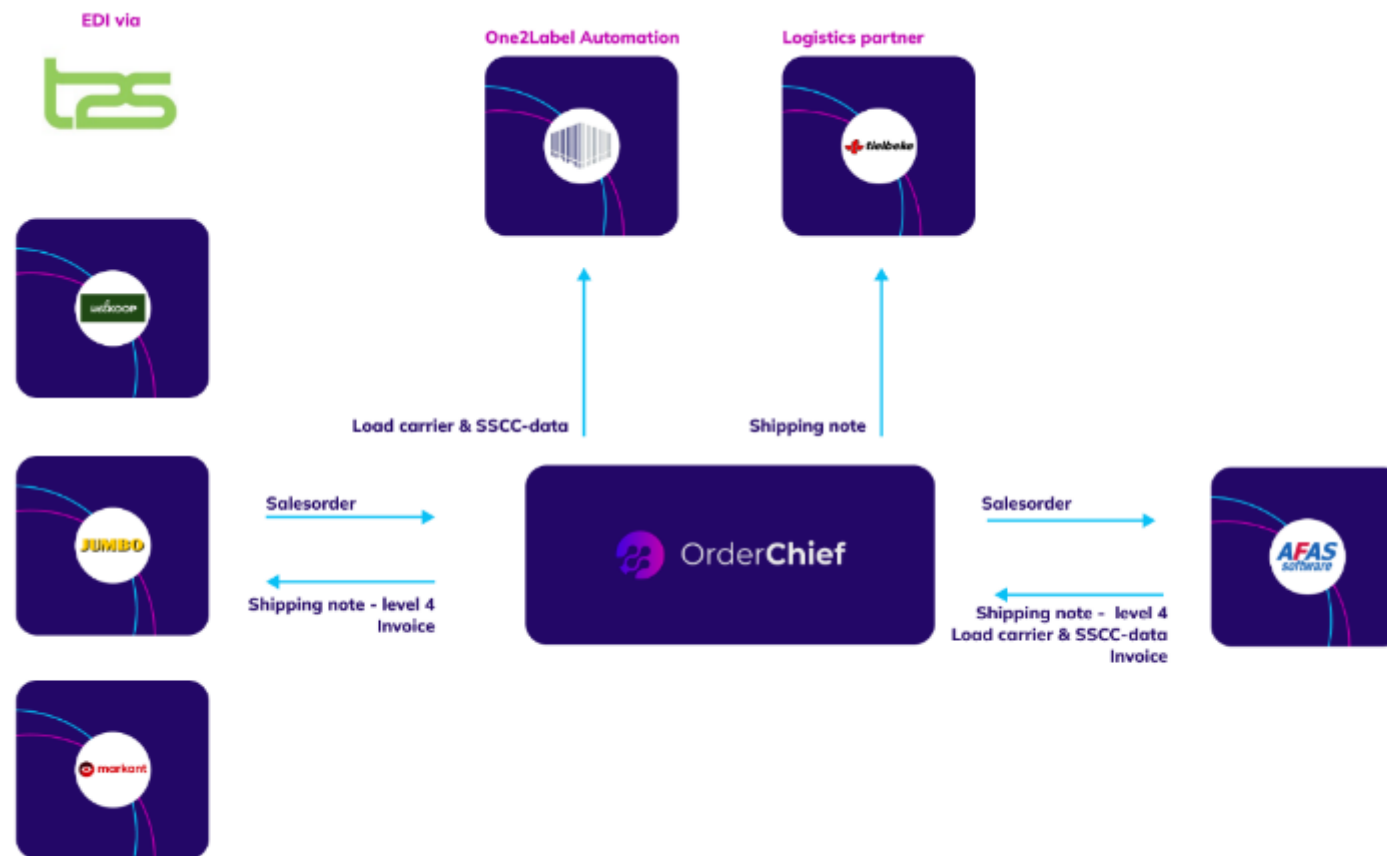

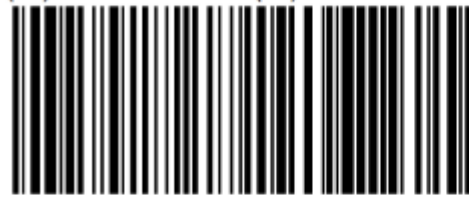

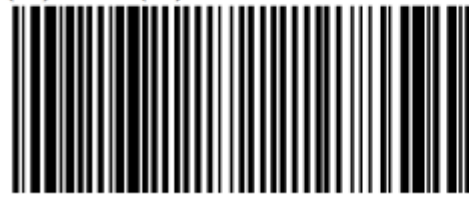

Pan European Public Procurement Online (Peppol)



Peppol enables the exchange of invoices in a safer, faster and more cost-efficient way than paper or PDF versions

For certain business transactions with the Dutch government or specific countries, e-invoicing via Peppol is even mandatory

Belgium: e-invoicing via Peppol will be mandatory for all VAT-liable businesses for business-to-business (B2B) transactions as of January 1, 2026

Connect once, reach all



When a company joins the **Peppol network**, it registers its participant details, and the document types it can handle.

This information is published in the Peppol Service Metadata Locator (SML), a shared **registry** that allows other participants to discover and connect with one another.

To exchange documents, each participant uses a certified **access point**, which acts as the communication channel for sending and receiving messages over the Peppol network.

To e-invoice through the Peppol network, you need a **Peppol ID**.

With this number, you can be found in the network and receive and send electronic messages. A Peppol ID can be a Chamber of Commerce, VAT, or IBAN number, but also, for example, a GLN.

Then, the sending party can send files directly to the framework. All the receiver identifying information is contained in the document.

EU Regulation on Deforestation - free Products (EUDR)



Postponed for medium-sized and large companies to December 30, 2026, and for SMEs to June 30, 2027

- Cattle, cocoa, coffee, palm oil, rubber, soy, wood and their derivatives, such as chocolate

Due Diligence Statement per production batch placed on or exported from the EU market, numbers must be shared with trade partners

EDI – DESADV

- DDR (Due Diligence Reference Number) - The unique EUDR Due Diligence Reference Number that is returned when the due diligence is registered on the EU platform
- DDV (Due Diligence Verification Number) - EUDR Verification Number that is created automatically by the system when registering a Due Diligence
