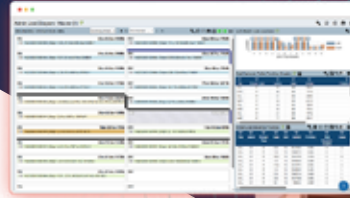

How it Works



End-to-End Workflow

Routed Sales Order Intake

Routed customer orders flow into LoadBuilder from your OMS or ERP. No WMS required, just pick sequence information.

Pallet Composition

LoadBuilder determines optimal pallet contents, applying product compatibility, weight, and temperature rules.

Warehouse Selection

Items are selected and pallets are built based on guidance from LoadBuilder, utilizing your existing selection process, and staged for loading.

Truck Load Optimization

Pallets are placed on the truck in optimal sequence: FILO, weight balance, zone compliance enforced automatically.

Load Sheet & Documentation

Dock team receives a complete, rule-verified load sheet. Compliance documentation generated automatically.



Integration Workflow

WMS Generates Pallets

Your existing WMS handles selection and pallet composition as it does today. No change to upstream processes.

Pallet Data Feeds LoadPlanner

Completed pallet data (dimensions, weight, contents, temperature zone) passes to LoadPlanner via integration.

Optimal Truck Placement

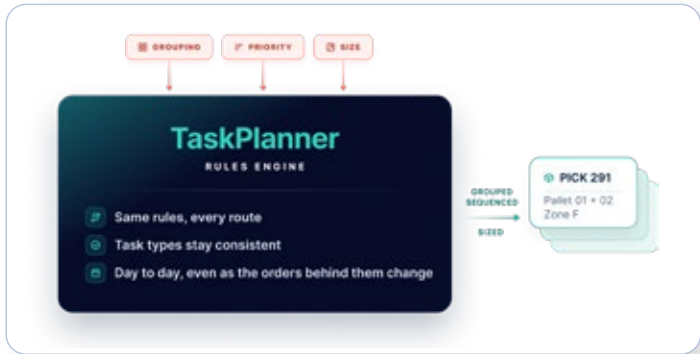
LoadPlanner determines the ideal placement for every pallet: FILO sequence, axle balance, zone compliance, stacking rules.

Load Sheet Delivery

Dock team receives LoadPlanner's optimized load sequence: clear, rule-verified, immediately actionable.

TaskPlanner™ is available as a built-in option that takes it a step further, applying the grouping, priority, and size rules your operation runs by to turn that load diagram into tasks: sets of work sized and sequenced the way your crew operates.
