Dear Chair Collins, Vice-Chair Murray, Chair Hagerty, and Ranking Member Reed:

We, the undersigned, urge you and your fellow members of the U.S. Senate Committee on Appropriations and Subcommittee on Financial Services and General Government to fully support the District of Columbia Courts' Fiscal Year (FY) 2027 budget request. Full funding at the requested FY 2027 levels for operations and capital improvements is necessary for our community's Courts to serve their crucial role in protecting public safety in the Nation's Capital and providing for the fair and timely administration of justice.

For the last four fiscal years, the D.C. Courts have managed to maintain their core operations with roughly level funding, despite the impacts of inflation and compounding infrastructure needs. **But now, in 2026, as the number of criminal prosecutions and civil matters rise even more sharply, the D.C. Courts are under severe strain to meet the needs of the District's residents and visitors. Specifically, from FY 2023 to FY 2025, new civil and domestic relations case filings have increased 33%; criminal case filings have increased 160%.** These increases must be accompanied by budget increases or litigants and the public will suffer.

We are grateful that the Senate successfully filled numerous judicial vacancies on the D.C. Court of Appeals and Superior Court this year, including the eight confirmations on August 7. We are pleased that the Courts will soon be able to operate with a more complete roster of judges. **Judges cannot deliver justice on their own, however. They must be supported by professional court staff, reliable technology, robust security, and up-to-date capital infrastructure to adjudicate cases.** Thus, while the prospect of new judicial officers in D.C. is exciting, each added judge will heighten the need for fully funded D.C. Courts.

The D.C. Courts' Critical Role in Public Safety and the Delivery of Justice

Comprised of the D.C. Court of Appeals (D.C.'s equivalent of a state-level supreme court), the Superior Court (our trial court of general jurisdiction), and the Court System, the District's judicial branch is not simply another government agency, nor does it follow the same structure or funding as Article III federal courts. Rather, these courts are an integral component of the District's public safety foundation.

Federal and local officials, as well as D.C. residents, share Congress's goal to ensure that criminal and civil cases are promptly, fairly, and efficiently resolved. Recent changes in relevant laws and prosecution practices have resulted in a substantial increase in criminal case filings and in greater pre-trial detention of those who have been arrested. A corresponding increase in the Court's capacity to process these cases is essential to ensure fairness and confidence in the judicial system: every arrest, grand jury proceeding, prosecution, juvenile proceeding, pretrial detention hearing, trial, and appellate review depends upon sufficient operational capacity of the Courts.

We all can agree that the agencies comprising the justice system, such as those responsible for supervising defendants before trial or after sentencing, assisting victims, housing and caring for incarcerated persons, or integrating returning citizens back into the community, depend on efficient courts. Victims deserve to feel safe, have timely resolution of cases, and accountability for those who harmed them. Individuals charged with crimes deserve to have their Constitutional rights protected as they face life-changing consequences and the potential loss of liberty for their alleged actions.

Additionally, the Courts must also have adequate resources for the timely adjudication of civil matters, including a range of commercial disputes as well as child custody cases, domestic relations matters, the probating of estates, employment and housing cases, and a panoply of other non-criminal proceedings. **Businesses and everyday people in the District rely on our courts to address their legal disputes in a reasonable amount of time. As noted, these filings have increased 30% in the last three fiscal years.** Without sufficient tools and staff to advance cases through the many stages of civil litigation, cases can drag on for years. This can – and does – lead to unintended ripple effects on families, business owners, employees, and the economy of the District of Columbia.

The D.C. Courts Serve a National Interest

The D.C. Courts serve not just the needs of District residents but also ensure safety and fairness for the 27 million tourists who come to the city each year. Members of Congress and their staffs, private employers, non-profits, and foreign government personnel also depend upon the D.C. Courts to assure proper administration of justice. Given D.C.'s unique role in our federal structure, Congress has a unique and vital responsibility to appropriately fund the Courts.

The Courts' Budget Must Be Fully Funded to Fulfill Core Needs

Congress has been presented with a budget designed to meet today's needs, but the current recommendation for FY 2027 by the House Committee on Appropriations proposes a reduction

of nearly 13% from the FY 2026 budget, even though criminal and civil case filings have increased significantly. As noted above, the budget proposed by the D.C. Courts for FY 2027 follows years of fiscal austerity. **Currently, D.C. Courts operate with staff levels well below levels of ten years ago, jeopardizing their ability to meet security and case management needs, which are central for the people served by the courts.**

Specifically, the D.C. Courts face distinct and mounting challenges that require more resources than the House's proposal would provide. Security threats to court buildings and judicial officers are an escalating concern not just at the U.S. Supreme Court, but among our local judiciary as well. Our Courts manage a trove of non-public personal information and proprietary business data. Hackers, ransomware, and other cyber threats are a persistent danger, so dynamic information technology protections are a constant requirement. The adoption of artificial intelligence tools promises to introduce new efficiencies, but AI implementation requires technically savvy staff and sophisticated technology infrastructure.

While the Courts have worked hard to stay ahead of these challenges through improved productivity, targeted reductions, prudent fiscal management, and systematic strategic planning, the options for struggling through with inadequate resources have now been exhausted. In FY 2027, even continued static funding will diminish the Courts' ability to administer justice effectively and safely, especially with the eight newly confirmed judges set to join our courts.

Conclusion

Congress and the President have made clear their shared goals to improve public safety, reduce crime, increase operational efficiencies, and strengthen cybersecurity. Those are aspirations shared across the District of Columbia by the organizations and individuals who have signed this letter – all of whom care deeply about our community, the importance of an independent and effective judicial branch, and the principles of our Constitution.

Fully funding the D.C. Courts' operational and capital improvement budget requests for FY 2027 is an investment in our shared goals and will promote the fair and timely administration of justice for D.C.'s residents, those working in the District, and all who visit our Nation's Capital.
