Course Note:

"In the way of your testimonies I delight as much as in all riches. I will meditate on your precepts and fix my eyes on your ways. I will delight in your statutes; I will not forget your word. ... Your testimonies are my delight; they are my counselors." (Ps 119:14-16, 24 ESV).

Surely this is Jesus' own testimony. Covenant theology is, at its simplest expression, about the core structure of the Bible, revealing who God is, who we are, and how through God's Redeemer, our Savior, we can have a right relationship with God, an eternal one.

Learning to recognize the covenantal structure of Scripture is the beginning of learning to read the Bible the way Jesus does. This course will provide a foundation in this skill, one that the student can continue to build on throughout their walk of faith with Jesus.

Course Description:

This course introduces the student to the study of covenant theology from both the biblical theological and systematic theological perspectives. The course emphasizes the role that God's covenants play in structuring the Bible, and how these should apply in our reading and interpretation of Scripture. Applications will be made to the ordinary means of grace (preaching, teaching, sacraments, prayer), as well as the three primary contexts of Christian ministry (worship, discipleship, and evangelism).

Course Objectives:

- Developing the student's understanding of biblical covenants:
 - o Be able to articulate the differences between the biblical theological and the systematic theological approaches to covenant theology, and their mutual benefits.

- Memorize a brief description of the three main biblical covenants (redemption, works, grace), with a critical Scripture reference for each.
- Be able to outline the progressive development of the three main biblical covenants throughout Scripture.
- Motivating the student's biblical reading and interpretation skills through biblical covenants:
 - o Learn how to identify the macro covenantal structuring of the Bible.
 - Learn how to identify expressions and/or inferences to the three main biblical covenants in any passage of Scripture.
 - Learn how the NT broadly demonstrates the fulfillment of each of the three main biblical covenants.
- Establishing the student's application of biblical covenants:
 - o Develop personal bible reading skills that include covenant structuring considerations.
 - o Identify strategies for using the Bible's covenantal structure in the three main areas of Christian ministry life (worship, discipleship, and evangelism).

Course Assignments:

<u>Lecture Quizzes</u>: the student will complete a quiz for each lecture in this course (12 classes). Questions in each quiz will be multiple choice and true/false, based on the material in the lecture notes for each class. In keeping with course objectives, these quizzes may be taken with notes and books available. The student is recommended to only refer to these when he is not sure of a

given answer. After completing each quiz, the student is to email the quiz to the professor for grading, no later than Thursday each week of class.

The student is to begin reading at the first italicized Latin page # (i), and finish at the last regular text Roman page #. After completing this reading, no later than the last date of semester, December 12, 2025, the student is to submit an email to the professor with the following affirmation:
