**Course Note:** This is a Video Conference course (VC).

**Course Description:** The goal of this course will be to help the student gain a better understanding of Presbyterian history and tradition. The student will learn about the broader Presbyterian tradition, but will also grasp the historical/theological issues that led to the current state of Presbyterianism.

### **Course Objectives:**

- The student becomes familiar with the key events, decisions, people and places in the history of Presbyterianism.
- The student can articulate how Presbyterianism developed historically.
- The student acquires intercultural skills by listening to Christians of the past, patiently hearing their voices and evaluating their paths.
- The students sees himself or herself as a member of Christ's one, holy, catholic, and apostolic Church.
- The student begins to make decisions by applying wisdom from past historical situations to current ministry and cultural context.
