Westminster Confession of Faith Syllabus

Course Description: This course is a study of the Westminster Confession of Faith. Since its origination in 1646, the Westminster Confession has served as the theological confession for many branches of Reformed Protestantism. In this study, the student will not only gain an understanding of the history of the document, but also will gain a clearer understanding of the need for confessions and creeds in the church today, as well as a greater appreciation and understanding of the core doctrines taught therein.

Course Objectives:

- Course Objectives should be:
 - o Gain greater understanding of the history and content of the WCF
 - Recognize the need for confessional and creedal Christian thought in the church today
 - See and comprehend the biblical foundation of the doctrines contained within the confession
 - Utilize the confession as a tool for Christian thought
 - Be able to apply the various doctrines to your own Christian life
 - Promote doxology as a result of right theology
 - Utilize the confession in professional settings
 - Those in church ministry will be better equipped to teach and apply the standards in their context (ex. Sunday School, Presbytery, etc.)
 - Counseling students will be better equipped to apply doctrine to particular cases (ex. How can chapter 8 of the confession help someone caught in sin or struggling with assurance?)

Course Requirements and Assessments:

- Course Reading (10%).
 - Students are required to submit via email the total percentage of reading completed.
- Midterm (20%).
 - The midterm will cover some of the basic history from Fesko as well as an outline of the confession what has been covered thus far (ex. Ch 1. Scripture, Ch 2. God, etc.).
- Final Exam (20%)
 - The final exam will focus on doctrinal short answer doctrinal focused questions, as well as the remaining outline of the confession.
- Research Paper OR Questions from Van Dixhoorn's study guide (50%).
 - Option 1 traditional research paper

- Topics may include: an exposition of a particular doctrine found within the standards; a historical aspect or debate from the assembly; the relationship and/or comparison of the WCF with other confessional documents, etc. Students are encouraged but not required to contact the professor to discuss paper topics.
 *Counseling students are encouraged to write a paper applying a particular doctrine to a case study. Please contact the professor for more details.
- Option 2 Study guide questions
 - Students will answer ALL of the questions from Van Dixhoorn's study guide. The answers should be 2-3 short but complete sentences in single space format.
 - O Students who choose this option are required to purchase the study guide. Students writing a research paper are *not* required to purchase the guide.

BTS Format, Style, and Writing Standards:

All research papers must be formatted in accordance with Turabian Chicago standards including the title page. All papers are to be #12 font Times New Roman and Double-Spaced. Any paper not conforming to these standards will automatically be dropped one letter grade. Please see the BTS Turabian Style Guide for more information on turning in papers and assignments.
