# **Course Description**

The Lampstand Conference is focused on promoting principles of Church Vitality and Revitalization. The conference covers topics such as: What is the Mission of the Church? What are the marks of a healthy church? What is a biblical theology of the church? The conference then splits into three tracks: Church Revitalization, Church Planting, and Next Level Leadership. Students will gain an understanding of the Biblical doctrine of the church and its Biblical leadership standards, as well as examining the ongoing process of church revitalization. Graduate students are required to attend the Church Revitalization track, unless granted special permission from the professor.

## **Course Objectives**

Upon successful completion of this course, the student will be able to:

- **Content:** To understand the biblical church profile and the pressing need of church revitalization, church planting, and pastoral leadership in North America, along with the related issues.
- **Content:** To acquaint the student with specific quality literature that deals with the issues of church renewal and revitalization, planting, and leadership.



- **Competency:** To develop a clear understanding of the implementation of the biblical principles of the church as applied to contemporary and contextual situations.
- **Competency:** To determine Biblical models and theological principles applicable to church vitality.
- **Competency:** To develop a plan for revitalizing a church that has lost its initial vitality (either a known church or an acquaintance church).
- Character: To identify those factors that bring church stagnation and decline, areas of church planting, and godly leadership.

### A Note on Required and Recommended Texts

Please note that the inclusion of any text in this syllabus (whether as **required**, **collateral**, **or recommended** reading) does not imply a full theological endorsement of all its contents by the professor or by Birmingham Theological Seminary.

Graduate-level study requires a robust and critical engagement with diverse viewpoints. Some texts are assigned precisely because it is important for students to understand their content and arguments firsthand, even if we disagree with certain positions the author takes.



### **Course Requirements & Assessments**

Course assignments are consolidated into a single, scaffolded capstone project: **The Church Revitalization Case Study**. This project is divided into two parts, supplemented by an initial reading report.

The two video conference follow-up sessions (**Feb 28** and **March 28**) will serve as mandatory workshops to develop Parts A and B of this project, respectively.

### 1. Reading & Conference Report (15% of final grade)

- **Description:** After completing the required readings (approx. 800 pages) and attending the Lampstand Conference, you will write a 5-7 page foundational report. This paper will synthesize the 3-4 most critical principles for church vitality drawn from the readings and conference sessions. You must explain how these principles will form the theological and theoretical basis for your case study.
- **Purpose:** This assignment assesses your comprehension of the core course content (Objectives 2, 4).
- **Due Date:** February 27, 2025 (before first VC workshop)

### 2. Revitalization Case Study: Part A - Diagnosis (35% of final grade)

- **Description:** You will select a church you are familiar with and write a 10-12 page diagnostic assessment. This single, integrated paper includes:
  - Historical & Health Analysis: A 10-15 year history identifying factors contributing to the church's current condition, including an assessment of its health indicators.
  - Leadership & Field Research: A leadership assessment of the church, supported by synthesized data from your interviews with at least two church leaders (e.g., vocational or lay leaders). The interview content should be used as evidence for your diagnosis, not submitted as separate reports.
- **Purpose:** This paper assesses your ability to identify factors of church stagnation and decline (Objective 5) and builds the factual foundation for your revitalization plan. The first VC session (Feb 28) will be a workshop for this assignment.
- **Due Date:** March 27, 2025 (before second VC workshop)

#### 3. Revitalization Case Study: Part B - Prospectus & Plan (50% of final grade)

- **Description:** This 10-12 page capstone paper is your complete plan for revitalization, building directly on the diagnosis from Part A. It must contain the following elements:
  - **Section 1: Foundational Vision:** The proposed Mission Statement, Vision Statement, and Affirmed Values for the church.
  - Section 2: Ministry Strategy: A detailed, 3-page explanatory document outlining the proposed ministry strategy to move the church toward vitality.
  - Section 3: Theological Integration & Summation: A final summation that uses



- content from *Embers to a Flame, 3D Leadership*, the Lampstand Conference, and other course readings to theologically justify and support your proposed plan.
- **Purpose:** This final project directly assesses the primary course competency: your ability to develop a comprehensive, theologically-grounded plan for revitalizing a church (Objectives 1, 3, 6). The second VC session (March 28) will be a workshop for this assignment.
- **Due Date:** April 18, 2025 (Course Close Date)
