A. Local Control & Accountability Plan Budget (LCAP): Updates on the LCAP

Budget development 2025-2026

Marcos Aguilar, Executive Director, updated the Council of Trustees on the budget regarding Charter Impact's work on the expenditure areas, line by line, to align with the LCAP budget as a mid-year report on the status. The mid-year report provided estimates.

Debbi Deal, contract personnel, presented the details of the Budget Development document to the Council of Trustees and new methodology that attaches invoices to each goal. Charter Impact will be coding expenditures with each goal and each action in line with LCAP. Debbie also informed the Council of Trustees that this budget provides estimates and Charter Impact will provide exact numbers by the due date of the LCAP budget.

B. Second Interim Financials

Debbie Deal, contract personnel, presented and reviewed the certified second-interim report created by Charter Impact to the Council of Trustees. Debbie updated the Council of Trustees that the Second Interim report required by the State of California and has to be approved by March 15 of each year.

Charter Impact provided a detailed Second Interim report of financial and attendance projections, cost of living adjustment (COLA), revenue performance, surplus revenues, and budget reductions.

Recommendations

Marcos Aguilar suggested a new financial model to support the school.

Minnie Ferguson, Executive Director, suggested a committee to meet weekly to address the gaps in the financial and educational model. Overall positive news regarding budget projection.

C. Freedom from Fear 2.0 Draft

Marcos Aguilar, presented the existing policy with updated language to just approval of Freedom from Fear from 2016, Salomon Zavala provided a packet from Public Council to do policy recommendations. Requesting policy updates that protects students, staff and community from unwarranted attacks. By approving of this policy, we are updating all of the other policies that are being updated to the board. We are incorporating Public Policy recommendations by Public Council and our legal counsel's guidance. These add up to 20 policy adoptions and directives to staff. Updated based on LAUSD's updated policy on FERPA and ICE enforcement. Date of adoption needs to be included on the updated policy.
