#### II. Standard Policies

#### A. Staffing: workforce reduction policies and plans

Debi Deal presents finances on Cost of Living Adjustments. Estimated projection is between 2.43% and 2.93% increase. Debi volunteered to help with next year's budget. Board decisions will be informed by the recommendations from the budget regarding freezing of staff hire and raises. Goals and actions added to the Local Control and Accountability Plan (LCAP).

LCAP to be approved in different meetings than the budget. Federal funding will have multiple scenarios because of the Department of Education. Funds may be dispersed through Congress instead. Testing and LCAP: math scores increasing and need to revise test scores to determine if additional funds toward student support is needed.

#### III. Academic Excellence

#### A. Student lunches

Debi Deal, contractor, is working with staff from the after school program and will add these numbers to the LCAP. Linked together with the LCAP, to add to the school after the last 5 years of excellent programs. Dr. Ernesto Colin suggested working with a new potential fundraiser and development personnel.





#### B. Sintli Summit

Marcos Aguilar, Executive Director, asked the Council of Trustees to join the talks with students. Dr. Vasquez would like to participate in the panel.

#### C. Climate Resilient LA

Marcos Aguilar updated the Council of Trustees about the signed petition with 3 key points: bring back traditional ecological knowledge, landback be recognized and Indigenous stewardship.

### D. Native Language Resurgence

Marcos Aguilar reported back on the native language resurgence and CALI combined. First language institute conference will bring in various tribal nations and members including Yurok, Chumash, Kumeyaay, Zapotecos and Nawas. Marcos Aguilar described the 10 year revitalization plan for language.

Partnering with statewide advocates in education for a robust program, state-wide campaign. Considering an Immersion program. Program will most likely start next year depending on the state budget.
