ELECTION PROCEDURES

As all positions listed above are uncontested, no ballot will be required. Members are reminded of the following:

1. All nominees have been verified as meeting the eligibility requirements under Articles 15.2 to 15.6 of the MSS Constitution.
2. Voting rights at the AGM are restricted to Ordinary Members who have been members of MSS for at least the preceding 12 calendar months, pursuant to Article 13.11.
3. Voting shall be by show of hands unless a secret ballot is requested and agreed upon by the majority of voting members present, pursuant to Article 13.10.
4. The quorum for the AGM is 25% of the total voting membership or thirty (30) voting members, whichever is the lesser, pursuant to Article 13.9.
