

END-USER LICENSE AGREEMENT ("AGREEMENT")

Last updated: May 8, 2018

Please read this End-User License Agreement («Agreement») carefully before using our Services.

By downloading and / or using the services, you agree to be bound by the terms and conditions of this Agreement.

This Agreement is a legal agreement between you (either an individual or a single entity) and Easymeeting and it governs your use of the Services made available to you by Easymeeting.

LICENSE

Easymeeting grants you a revocable, non-exclusive, non-transferable, limited license to download, install and use the Services strictly in accordance with the terms of this Agreement.

RESTRICTIONS

You agree not to, and you will not permit others to: modify, make derivative works of, disassemble, decrypt, reverse compile or reverse engineer any part of the Services. remove, alter or obscure any proprietary notice (including any notice of copyright or trademark) of Easymeeting or its affiliates, partners, suppliers or the licensors of the Services.

INTELLECTUAL PROPERTY

The Services, including without limitation all copyrights, patents, trademarks, trade secrets and other intellectual property rights are, and shall remain, the sole and exclusive property of Easymeeting.

YOUR SUGGESTIONS
